- 4. The Chairman kept the floor open for any other issues to be resolved. Several requestes regarding reduction in rates were made and the Chairman replied that as the rate in GST is a policy issue to be decided by the GST Council, the same cannot be taken by the RAC. Some of the RAC members informed that there is no possibility to ascertain whether Returns were filed by their suppliers or not as non filing of Returns posing difficulties in availing ITC. The returns filing status can be viewed in the GSTN portal itself as facilities are available for finding the status of filing of return by the taxpayer by typing their GSTIN. One of the members said that there are lot of difficulties in raising a large number of supplementary invoices wherever there is any change in the price after making supplies. The Chairman replied that Section 34 of the CGST Amendment Act, 2018 contains the provision for raising consolidated credit/debit notes and the issue will be resolved once the amendment act is made effective.
- 5. The meeting concluded with the vote of thanks to all the members present in the meeting and the Chairman informed that the date and venue of next RAC meeting will be communicated in due course.
