1	Public Notice No. 20/2018 dated 30.05.2018	The availability of Officer Interface to cases with erroneous declaration on payment of IGST, Invoice mismatch and cases where exporter has either declared different GSTIN in SB or has declared only PAN has been communicated.
2	Facility Circular No.03/2018 dated 30.05.2018	A dedicated IGST Refund Cell has been opened at New Custom House, Air Cargo Complex, Meenambakkam, Chennai to help the exporters overcome the obstacles in the processing of their IGST refund claims. Further, the contact details of Officers for further details, if any required for the purpose of expediting the IGST refunds have also been communicated.
