Sub: Precautionary efforts needed in GST & CX Offices to contain the spread of COVID 19 - representation dated 16.03.2020 received from the All India Association of C.Excise Gazetted Executive Officers', Chennai unit - reg. \*\*\*\*\*

The All India Association of Central Excise Gazetted Executive Officers', Chennai Unit jointly with the Chennai Unit of Inspectors' Association had submitted a Ten (10) point suggestion to the Principal Chief Commissioner of GST & Central Excise, Tamilnadu & Puducherry, regarding the precautionary efforts to be taken by the Chennai GST & Central Excise Zone to contain spread of COVID 19.

Taking cognizance of the above representation, the Principal Chief Commissioner of GST & Central Excise, Tamilnadu & Puducherry Zone has directed all the Commissioners to strictly ensure implementation of the following points in all the offices located under their jurisdiction with immediate effect:

- (a) All Visitors be screened properly with the thermal scanners
- (b) Proper sanitizers are installed at the all the entrance points of office buildings
- (c) All officers and staff in Hqrs. sections / Divisions / Ranges be equipped with
- (d) Frequent spray of disinfectants / sanitizers in and around the office premises incl. lift buttons, door knobs, almirahs, water dispensers, taps etc
- (e) Preventive and Audit Officers may be provided with appropriate safety equipment like sanitizers, gloves and masks.
- (f) Physical checks and verifications & E-way Bills may be halted till 31st March 2020.
- (g) MCM may be conducted with minimal strength (ie) with a maximum of 20 officers.
