No. II/ (39)/OTH/2150/2023-ADMN/88-106 dated 22.04.2025 (Letter-II) regarding Grant of Commendation Certificate on the occasion of GST Day, 2025 received from Principal Director General, DGGST, New Delhi.

2. It may be seen from Letter-I cited above that, the GST Day this year will be celebrated on 1st July 2025 with the theme "GST: Simplifying Taxes; Empowering Citizens".

The DGGST, New Delhi has directed all the Zones of CBIC to organize **Pre-GST Day activities (as suggested below) from 15^{th} to 31^{st} May, 2025 at the Zonal level / Commissionerate level to educate and engage various stakeholders. Any other activities apart from the activities mentioned below may also be included.**

- d) Cycle Marathon in coordination with the Fit India Campaign.
- 3. In this regard, all the Commissionerates of this Zone are kindly requested to ensure that the above-mentioned Pre-GST Day Activities are conducted in your Commissionerate from 15th to 31st May 2025 without fail. It is also kindly requested to ensure that the pictures and videos of the Pre-GST Day Activities conducted in your Commissionerates during the aforesaid period are captured and shared / sent to this Office through email to budget-prcco@gov.in & zabprcco.chennaicgst2025@gmail.com at the earliest by 31.05.2025 without fail / any delay. engagement, to be showcased during the main GST Day celebration event on 1st July 2025 in New Delhi.

- 4. Also, if any Commissionerate can be creative to make songs and poems on the theme of GST / taxation, it will be highly appreciated and such video may kindly be forwarded to this Office through email (to the aforementioned email IDs) by 16th May 2025.
- 5. Cycle Marathon is to be organized in coordination with the Fit India Campaign. Shri. Narendra Yadav, Additional Director, DGTS can be contacted in this regard (Contact Details: 9885444433).
- 6. This year as a part of GST Day celebrations, our focus shall be on taxpayer facilitation. Accordingly, it has been decided that GST Pakhwada shall be organized in all the zones by setting up of helpdesks to resolve trade issues and raise awareness from 16th to 30th June, 2025 culminating as a final function on 1st July 2025 wherein main event shall be organized in New Delhi and at each Zonal Head Quarter / Commissionerate Head Quarter. In this regard, a detailed letter regarding this would be shared by DGGST, New Delhi in due course.
- 7. The successful implementation of these activities will further strengthen the spirit of GST and its positive contributions to India's economy. You are also at liberty to include additional activities suitable for the celebration.
- **8.** Your cooperation and commitment in making this momentous occasion a grand success is highly appreciated.
- 9. It may be seen from Letter-II cited above that, the DGGST, New Delhi has sought nominations for Grant of Commendation Certificates to meritorious officers (maximum of three (3) per Zone). As per the protocol evolved, Commendation Certificates are awarded to the selected Officers in various grades at the all-India level, who, by their innovative ideas / continued devotion and commitment to duty, have contributed in promoting excellence in the fields of GST administration. The Objective is to give due recognition to officers who may have contributed significantly in diverse areas such as trade facilitation, automation, enforcement, audit, infrastructure development, human resource development, personal management, secretarial work, legislation, policy making, legal, judicial and training, which often remain unrecognized by the way of formal awards. These areas are suggestive and not exhaustive.
- **10.** In view of the foregoing, you are requested to forward well-deserved nominations / proposals of the officers for Grant of Commendation Certificates on GST Day, 2025 based on the following criteria:
 - a) APAR Grading for the last five years duly certified by the sponsoring authority.
 - **b)** Vigilance Clearance for the last five years.
 - c) Care should be taken to send proposals of only such officers whose integrity is absolutely beyond doubt.
 - **d)** Performance of the officer / Achievements / Initiatives etc. which have bearing on the performance of the department.
 - **e)** In the description of significant contribution made, the role of the Officer must be clearly brought out as distinct from that of the organization or team that the officer was a part of & also the details of instances / cases where the officer has played a prominent role should be mentioned separately indicating the exact role played by the officer.

- 11. In this regard, it is requested to shortlist the proposals of Officers (for Commendation) duly verified and with the recommendation of respective Principal Commissioner / Commissioner of the concerned Commissionerate, based on the above criteria and forward the nominations in the prescribed format (proforma enclosed to Letter-II cited above may please be referred) along with APAR Gradings & Vigilance Clearance for the last five years (duly signed by the Competent Authority) to this Office at the earliest by 09.05.2025 without any delay.
- 12. The Hard Copies of the proposals of Officers nominated for Commendation may be sent to this office through speed post & also Soft Copies with regard to the same may be sent through email (in both PDF & editable MS-word formats) to budget-prcco@gov.in & zabprcco.chennaicgst2025@gmail.com at the earliest by 09.05.2025 without any delay. In case if any officer who had already received Commendation Certificate prior to this date is again nominated this year, the same may be specifically stated in the forwarding letter.
- **13**. It is also requested that wide publicity may be given to this letter to encourage deserving officers in different grades i.e. Group 'A', 'B', 'C' to apply for grant of Commendation Certificate.
- 14. It is further requested that each Commissionerate may **nominate two nodal officers**, one in the grade of A.C. and one in the grade of Superintendent for liaison purpose. The Officers name, designation, mobile number and gov mail ID may be **sent before 31.04.2025**.

The objective is to give due recognition to officers who may have contributed significantly in diverse areas such as trade facilitation, automation, enforcement, audit, infrastructure development, human resource development, personal management, secretarial work, legislation, policy making, legal, judicial and training, which often remain unrecognized by the way of formal awards. These areas are suggestive and not exhaustive.


- 3. For this purpose, the (Pr.) Chief Commissioners/ (Pr.) Director Generals may kindly send **maximum of three (03)** suitable nominations with recommendations. The officers, who consider themselves deserving for the commendation may apply to their Commissioners/ controlling officers (in the enclosed proforma) who, after due scrutiny, shall forward their applications to the concerned (Pr.) Chief Commissioner/ (Pr.) Director General. In the description of significant contribution made, the role of individual must be clearly brought out as distinct from that of the organization or team that the officer was a part of. Details of instances/cases where the officer has played a prominent role should be mentioned separately indicating the exact role played by the officer.
- 4. You may also ensure that the abstract showing the APAR grading of the officer for the last five years duly certified by the sponsoring authority accompany the proposal. The vigilance clearance for the last five years should also be furnished along with the proposal. Care should be taken to send proposals of only such officers whose record of integrity is absolutely beyond doubt. At the time of sponsoring the names itself, the sponsoring authority should satisfy that the officer is really a deserving candidate for the award and also enjoys an excellent general reputation.
- 5. It is also requested that wide publicity may be given to this letter to encourage deserving officers in different grades i.e. Group 'A', 'B', 'C' to apply for grant of Commendation Certificate.
- 6. The proposal duly verified and with the recommendation of respective (Pr.) Chief Commissioner/ (Pr.) Director General should be sent to this office latest by 15.05.2025. As time is short, the proposals without your recommendations or advance proposals etc. or the proposals received after 15.05.2025 will not be considered. The nomination in the enclosed proforma in word format along with abstract of APAR and Vigilance status should be sent by e-mail to: <dqgst-cbic@gov.in> and by

15.05.2025. Word format is insisted as it enables faster processing. A hard copy should also be sent by Speed Post.

7. I would like to reiterate that the complete deserving proposal (max 3) should be sent within the stipulated date through (Pr.) Chief Commissioner/ (Pr.) Director General only in word format and with abstract of APAR and current Vigilance Status to enable further processing.
