## OFFICE ORDER No. 06/2019

Sub: Framing of policy for deputation of ministerial Officers to other organizations

This office has been receiving requests from Tax Assistants for deputation to other organizations. In order to deal with such requests it has become necessary to frame a policy for considering the same.

- 2. Keeping in mind the acute shortage of Tax Assistants in Chennai Cadre control zone (working strength currently being only 35%) and more importantly the fact that Inter Commissionerate transfer (ICT) is permissible as per the RR of Tax Assistants and also the fact that ICT is being considered after completion of three years, the requests for Deputation /Loan basis by Tax Assistants shall not be considered unless the working strength reaches 70%.
- 3. However Tax Assistants who are denied of an opportunity to go on ICT's or have not completed the eligible tenure of three years to be under the consideration zone for ICT, but have genuine exceptional circumstances may be considered for deputation under extremely compassionate grounds.
- 4. All other conditions remain the same as followed for the executive cadres. viz.a.viz. completion of two years of service in the grade and not more that 4 representations for deputations to various organizations in a year.
- 5. It is also emphasized that representations/willingness to the Directorates/organsiations should be routed through the Principal Chief Commissioner's Office only. No advance copies must be sent. Representations from the Directorates/organisations recommending an individual will be viewed strictly.
- 6. This is issued with the approval of the cadre Controlling authority for TamilNadu and Pondicherry.
