Kind attention is invited to the references issued by the Board on the above subject.

2. It is proposed to draw a panel of Inspectors of GST & Central Excise for posting as ACO in Anna International Airport, Chennai against the following vacancies meant under the 25% quota.

3. The guidelines terms and conditions as contained in the Air pool policy issued vide Board's letter dt. 15-02-2019 are applicable in respect of selection of the officers. The period of posting at Airport is initially for two years and it may be extended by

one more year, subject to the willingness of the officer and acceptance by the Chief Commissioner of Customs, Chennai Zone. However, an officer posted to the Airport can be reverted to his/her parent zone at any time before completion of his/her tenure on administrative grounds. The officers posted at the airport shall be considered as on deputation to the Airport, but no deputation allowance is admissible to them.

4. The following officers are not eligible for posting to Anna International Airport, Chennai:
  - a. Officers who have not completed two years of cooling off period after completion of their tenure in DGRI/DGCEI(DGGI)/NCB/Enforcement Directorate/EIB or any other International Airport as on date of issue of this letter.
  - b. Officers who are due for superannuation within two years as on date of issue of this letter.
  - c. Officers transferred out of Airport/Sensitive postings on administrative grounds.
  - d. Officers having vigilance cases pending against them or those in ODI/ Agreed list.
  - e. Officers against whom penalty is operative.

5. On receipt of willingness applications from the officers of your Zone, the selection process as contained in the Board's letter F.No.A-11019/16/2018-Ad.IV dated 15/02/2019 may please be taken up and the names of the selected officers may be intimated to this office on or before 28-02-2024. No specific number of posts has been earmarked for any particular zone.
