### AMENDMENT No.02 TO TRANSFER POLICY 2022 FOR SUPERINTENDENTS

Please refer to the Transfer Policy 2022 for Superintendents issued on 20.05.2022, Corrigendum to the Transfer Policy issued on 26.10.2023 and Amendment to the Transfer Policy issued on 29.03.2025.

02. The following amendments are made with immediate effect in the above Transfer Policy, 2022 dated 20.05.2022 read with Corrigendum dated 26.01.2023 and Amendment dated 29.03.2025.

## 03. **Para 9.5** of the Transfer Policy is substituted as below:

"The maximum tenure in the grade of Superintendent in Trichy CC(P) Zone will be for a period of 08 years subject to maximum cap of continuous tenure of 12 years in the grades of Inspector and Superintendent combined; However, based on representations, subject to administrative exigencies and availability of vacancies, the officers who complete a minimum of 02 years in a station within Trichy CC(P) Zone will be considered for transfer out of Trichy CC(P) Zone,".

Note: However only for this year (AGT 2025), the officers in the grade of Superintendent who have completed continuous tenure of 08 years in Trichy CC(P) Zone and also 04 years in each of the Commissionerates of Trichy CC(P) Zone only will be transferred out of Trichy CC(P) Zone during Annual General Transfer 2025. Further, with effect from Annual General Transfer 2026 onwards, the officers in the grade of Superintendent, who have completed continuous tenure of 08 years or more in Trichy CC(P) Zone, irrespective of the tenure in the individual Commissionerates of Trichy CC(P) Zone, will be transferred out of Trichy CC(P) Zone.

- 04. All other guidelines and clauses laid out in the Transfer Policy dated 20.05.2022, Corrigendum dated 26.10.2023 & Amendment dated 29.03.2025 remain unaltered.
- 05. This is issued with the approval of the Principal Chief Commissioner.
