Willingness is called for from the Superintendents/Inspectors, ***who have not worked in any of the international airports for a period of over 6 months***, for the post of Air Customs Superintendent and Air Customs Officer (ACO) on deputation to Indira Gandhi International Airport, New Delhi. The officers are directed to submit their willingness along with bio-data, history of postings to their respective Commissionerates on or before **05.09.2023**. Any application received as advance copy and not forwarded through proper channel will not be considered.

3. All the HODs are requested to forward the willingness from the officers along with bio-data, history of postings, APAR gradings for last 5 years (**2018-19 to 2022-23**), Vigilance Clearance Certificate indicating major/minor penalty if any imposed during the last 10 years/ in currency and Integrity Certificate positively by **07.09.2023**. The cut-off date specified above may be strictly adhered to. Any willingness received after the due date will not be entertained by this office. Hence, Commissionerates are requested to ensure that the duly forwarded applications reach this office by the cut-off date and if no applications are received, a 'NIL' report may be sent without fail on or before the cut-off date.
