Officers who do not have the responsibility of adjudication or have completed their adjudications for the financial year 2019-2020, shall be relieved on or before 16.08.2024 and must join at their new place of posting on or before 29.08.2024.

- 3. The compliance report regarding the relieving and joining of the above officers may be sent to this office by 02.09.2024.
- 4. All representations received till date regarding the posting and transfer in the grade of Deputy / Assistant Commissioners stand disposed off. No representations whatsoever shall be entertained before the officers join at their new place of posting.
