Consequent to the Annual DPC for the year 2024 held on 29.12.2023 and Review DPC held on 08.02.2024, the following Inspectors of GST & Central Excise are promoted on **Regular Basis** to the grade of Superintendent of GST & Central Excise in the pay Matrix at the Level-8 as per 7th Pay Commission, with effect from the date shown against their names. The promotion will be effective only from the date on which the officers assume charge in the promoted grade as Superintendent in Central GST and Central Excise, Tamil Nadu & Puducherry Zone.

02. The officers presently posted in Tamil Nadu & Puducherry Zone and Trichy CC(P) zone are promoted on in situ basis. The officers on deputation basis/ Loan basis in other formations, shall repatriate back to CCA, Chennai for assuming charge as Superintendent in CCA-Esst section, Office of the Principal Chief Commissioner of GST & Central Excise, Chennai 600 034. In terms of G.I Dept. of Per & Trg; O.M No.16/7/90-Esst(Pay-I), dated the 9th September 1992 and 20th March, 1995 their controlling officers are required to relieve

them immediately on receipt of this promotion order. Their promotion will be effective only on joining this office and the delay in relieving them from deputation / loan will cause pecuniary loss to the officers.

03. The Seniority of the officers will be fixed as per the instructions in force.

04. The officers promoted on Regular basis should exercise their option for fixation of pay in terms of F.R.22(I)(a)(1) within one month from the date of joining as Superintendent. The officers who have already been granted Financial upgradation under Assured Career Progression Scheme / Modified Assured Career Progression Scheme are not entitled for pay fixation benefits now.

05. The promotion now ordered is subject to outcome of the following:

- (i) Writ Petition in W.P.C.T. 261/2008 filed by Shri Samiran Roy & Others pending before the Hon'ble High Court, Calcutta in terms of Board's letter F.No.C-18012/6/2009 Ad IIB dated 16.09.2010.
- (ii) Jarnail Singh batch of cases in SLP (C) No.30621 of 2011 pending in Hon'ble Supreme Court of India.
- (iii) Other cases, if any, pending before any judicial fora.

06. Further, the respective controlling officers concerned shall ensure that, in case the Inspector whose name is figuring in this promotion order is under suspension / undergoing Disciplinary or prosecution proceedings / is under penalty period etc, such officer should not be relieved or allowed to assume charge as Superintendent and the fact should be brought to the notice of the Cadre Control Authority immediately.

07. On assumption of charge as Superintendent in GST and Central Excise, Tamil Nadu & Puducherry Zone, the promoted officers will continue to work in their present place of posting until regular posting orders are issued.

08. The officers who are promoted shall assume charge as Superintendent in GST and Central Excise, Tamil Nadu & Puducherry Zone within 10 days from their date of promotion or within 10 days from their date of relief (for officers who are currently posted outside GST and Central Excise, Tamil Nadu & Puducherry Zone).

09. The compliance report about the joining/non-joining of the officers on promotion to the higher grade should be sent to this office by the concerned Commissionerate within two days from the last date for joining on promotion.

10. This order is issued with the approval of Principal Chief Commissioner, GST & Central Excise, Tamil Nadu and Puducherry Zone.
