Sub: Calling of willingness from Superintendents to serve
in Special Economic Zone as Authorised officers – Reg.

It is informed that one officer working as authorised officer in SEZ, Trichy region is nearing completion of eligible tenure. Hence, it has been proposed to empanel one officer against the vacancy arising in MEPZ, SEZ Tamil Nadu & Puducherry on transfer basis based on Willingness/Seniority/ APAR gradings/Vigilance status and in terms of this office Circular dated 09.08.2023 (Copy enclosed).

2. All Superintendents of GST and Central Excise, Tamil Nadu & Puducherry who have not completed 56 years of age as on the last date for receipt of application i.e **05.07.2024** are eligible for consideration. However, superintendents who had previously worked in SEZs as Authorised officer are not eligible for posting again in SEZ and they should not apply. The normal period of posting in SEZ is two years. It is extendable by one year at the discretion of Office of MEPZ-SEZ. Officers once selected for a particular SEZ Region should not request for change of Region. Officers are liable to be transferred back before completion of their normal tenure if their work is not found satisfactory in SEZ and they cannot apply again for SEZ posting.

3. It is requested that this may be kindly circulated among all the Superintendents working under your charge. The willingness of Superintendents received in the prescribed format, if any, along with their vigilance clearance and APAR grading for

the last 5 years, may be sent to this office on or before **05.07.2024** positively. The officers may submit their Advance copy of applications and its enclosures, if any , through IT platform in the link uploaded in the Zonal website . However, the applications received through proper channel only will be taken for further processing.



CIRCULAR

Sub: Posting of Group B officers of Chennai GST Zone to Madras
Export Processing Zone (MEPZ) Special Economic Zone (SEZ) –
Reg.

The following policy/ guidelines are framed for posting of Group B officers to various SEZs under the administrative control of Development Commissioner, Madras Export Processing Zone, Special Economic Zone.

1. Posting of Group B Officers working in Chennai GST Zone to MEPZ, SEZ will be considered, against the vacancy circular issued, based on the willingness expressed by the Officers and on the criteria of Seniority, APAR gradings and Vigilance clearance.
2. The selection will be for the SEZs at various locations viz. Chennai, Coimbatore, Salem, Madurai (including Tirunelveli, Tuticorin), Trichy and based on the options for such locations submitted by the officers.
3. The officers falling under the following categories are not eligible for posting to MEPZ, SEZ:-
 - a) The officers under the administrative control of other Zones / Cadre Control Authorities;
 - b) Officers who had previously worked in any SEZ for a period of 6 months or more;
 - c) Officers working in any Directorates / Airports either on Deputation or loan basis and HPU/ECM of Commissionerates;
 - d) Officers who have worked in any Directorates / Airports either on Deputation or loan basis and HPU/ECM of Commissionerates, but have not completed the cooling off period of 2 years.
 - e) Officers who had attained 56 years of age as on the last date for submission of willingness.
4. This is issued with the approval of Principal Chief Commissioner.
