 - i) 3 Sets of Colour photographs of size 5cm x 7cm to be pasted on the Attestation Forms.
 - j) 3 Sets of Colour passport size photographs.
4. Also please find enclosed the format for Identification and Character Certificate (The same is required to be obtained from two different Gazetted officers of the Central or State Government or Stipendiary Magistrates who have known the candidate for a minimum period

1/945375/2022 of two years) in three original sets which are to be submitted duly certified at the time of reporting this office.

5. After having completed Document Verification, the candidates will undergo Physical Endurance Test which will include walking and cycling.
6. Also, if the candidate has been issued with any Show Cause Notice (SCN), the reply of SCN along with proof of having sent the reply to the SSC should be brought at the time of verification without fail.
7. It may be noted that the candidates have to make their own arrangements for boarding and lodging during the stay. No travelling or other expenses will be paid by the Department for attending the Certificate verification and physical endurance test.
8. In the event of not reporting on the prescribed date for the document verification/ Physical Endurance Test, it will be presumed that they are not interested in accepting the offer of appointment in the department and all consequences arising out of the non-reporting shall come into effect.
