2. The Candidates are given **third and final chance** to report in this Office for verification of Original Certificates & Physical Endurance Test on **07.07.2021 and 08.07.2021**. No further extension or representations for attending DV/PET on a later date will be entertained.

3. While reporting, the candidates are required to submit the duly filled in Attestation forms available in the Chennai Central Excise Website in **three sets in original** without fail along with **original** certificates in proof of:

- (i) Date of Birth
- (ii) Educational Qualifications
- (iii) Community Certificate, if applicable
- (iv) PH/ Ex- Serviceman Certificate, if applicable
- (v) Aadhar Card and PAN Card
- (vi) RT-PCR Test Report dated not before 05.07.2021.
- (vii) Any other relevant document (which the candidate feels is necessary)

4. Also please find enclosed the format for Identification and Character Certificate (The same is **required to be obtained from two different gazetted officers who have known the candidate for a minimum period of two years**) in **three original sets** which are to be submitted duly certified at the time of reporting this office.

5. After having completed Document Verification, the candidates will undergo Physical Endurance Test which will include walking and cycling.
6. Also, if the candidate has been issued with any Show Cause Notice (SCN), the reply of SCN along with proof of having sent the reply to the SSC should be brought at the time of verification without fail.
7. It may be noted that the candidates have to make their own arrangements for boarding and lodging during the stay. No travelling or other expenses will be paid by the Department for attending the Certificate verification and physical endurance test.
8. In the event of not reporting on the prescribed date for the document verification/ Physical Endurance Test, it will be presumed that they are not interested in accepting the offer of appointment in the department and all consequences arising out of the non-reporting shall come into effect.
9. You are further informed that no further extension of time will be granted.
