- O2. All the promoted officers will continue to work in their present place of posting (including those working on Loan Basis) till regular posting orders are issued.
- O3. However, the officers working on deputation basis should repatriate back to PCCO and assume charge as Superintendent in CCA-Estt section, Office of the Principal Chief Commissioner of GST & Central Excise, Chennai-34. Their promotion as Superintendent will be accepted only on joining in CCA-Estt Section.
- 04. The officers promoted on Adhoc basis are not entitled to exercise option for fixation of pay and the promotion does not confer on the officers so promoted any claim for continued officiation in the grade of Superintendent of GST & Central Excise and the period of such service will not be counted for seniority or as qualifying service for further promotions.
- 05. The promotion now ordered is subject to outcome of the followings.

No. A.32022/70/2003 AD-III A dated 26.09.2005. Therefore, the promotion of this officer to the grade of Superintendent is also subject to the outcome of above SLP.

(iv) Other cases, if any, pending before any judicial fora.

- 06. Further, the Commissioner concerned shall ensure that if the Inspector whose name figuring in this promotion order is under suspension or facing any Disciplinary proceedings or prosecution or under penalty period, such officer should not be relieved or allowed to assume charge as Superintendent. This fact may be brought to the notice of the Cadre Control Authority immediately.
- 07. The promotion now issued is subject to the condition that the officers concerned join latest by 16.01.2019 (except the officer mentioned at Sl.No 2,3 & 4 viz Shri/Smt M E Caroline Grace, Manoj Kumar and Vijay Bhushan who should join latest by 12/04/2019, 29/04/2019 and 24/05/2019 respectively) failing which it will be treated that they have not accepted the promotion *ab initio* and all consequences arising as a result of non-acceptance of promotion shall follow.
