- They should exercise their option for fixation of pay in terms of F.R.22 I(a) (i) within one month from the date of joining as Motor Car Driver Grade-II. The Motor Car Drivers who have already been granted financial upgradation under Assured Career Progression Scheme/Modified Assured Career Progression Scheme are not entitled for pay fixation benefits now.
