3. The seniority of the Motor Car Drivers in Grade-II will be fixed as per the orders in force.

4. They should exercise their option for fixation of pay in terms of F.R.22 I(a) (i) within one month from the date of joining as Motor Car Driver Grade-II. The Motor Car Drivers who have already been granted financial upgradation under Assured Career Progression Scheme/Modified Assured Career Progression Scheme are not entitled for pay fixation benefits now.
