

- O2. All the newly promoted officers will continue to work in their present place of posting (including those working on Loan Basis) till regular posting orders are issued.
- 03. However, the newly promoted officers working on deputation basis should repatriate back to PCCO and assume charge as Superintendent in CCA-Estt section, Office of the



Principal Chief Commissioner of GST & Central Excise, Chennai-34. Their promotion as, Superintendent will be effective only on joining this office.

- 04. The Seniority of the officers will be fixed as per the orders in force.
- The officers should exercise their option for fixation of pay in terms of F.R.221(a)(i) within one month from the date of joining as Superintendent. The officers who have already been granted Financial upgradation under Assured Career Progression Scheme / Modified Assured Career Progression Scheme are not entitled for pay fixation benefits now. The pay shall be fixed with effect from the notional date and arrears of Pay and Allowances will be payable from the date of actual assumption of charge as Superintendent in terms of FR 17.
- 06. The promotion now ordered is subject to outcome of the followings.
 - (i) Writ Petition in W.P.C.T. 261/2008 filed by Shri Samiran Roy & Others pending before the Hon'ble High Court, Calcutta in terms of Board's letter F.No.C-18012/6/2009 Ad IIB dated 16.09.2010.
 - (ii) Other cases, if any, pending before any judicial fora.
- The effective date of promotion of newly promoted officers mentioned at Sl.Nos 1,41,42,86,91, 126 to 133 above who have completed the training will be the next day after the date of completion of training. The senior officers who fulfill one of the eligibility criteria of completing the mandatory Training prescribed in the Recruitment Rules, 2019 at a later date, are not eligible to claim any stepping up of pay in terms of Para 3(b) and (d) of DOPT O.M No.4/3/2017-Estt (Pay-I) dated 26.10.2018.
- 68. Further, the Commissioner concerned shall ensure that if the Inspector whose name figuring in this promotion order is under suspension or facing any Disciplinary proceedings or prosecution or under penalty period, such officer should not be relieved or allowed to assume charge as Superintendent. This fact may be brought to the notice of the Cadre Control Authority immediately.
- 09. The promotion now issued is subject to the condition that the newly promoted officers concerned join latest by 15.12.2021 failing which it will be treated that they have not accepted the promotion *ab initio* and all consequences (including postponement of MACP benefits), arising as a result of non-acceptance of promotion shall follow.
- 10. The compliance report about the joining/non-joining of the officers should be sent to this office by the concerned Commissionerate latest by 16.12.2021.
- 11. This order is issued with the approval of the Chief Commissioner, GST & Central Excise, Tamil Nadu and Puducherry Zone.
