The undersigned is directed to say that one post of Administrative Officer in the Pay Band 3 Rs.15600 - 39100 + Grade Pay of Rs.6600/- (Level-11 in the Pay Matrix - revised) in the Income Tax Settlement Commission, Additional Bench. Officers under the Central Government:

The Departmental Superintendent in the Pay scale of Rs.6500-200-10500 (Level-7 in the Pay Matrix - Revised) of the Bench concerned with eight years' regular service in the grade shall also be considered along with outsiders.
