ORDER NO. 78 /2019

Sub:Review DPC held on 13.09.2019 to review the DPC held on 13.04.2017 for promotion to the grade of Inspector, and consequent issue of Promotion Order No. 36/2017 vide C.No: II/03/40/2017-CCA-Estt, dated 18.04.2017 -Withdrawal of Promotion orders as per Board's directions issued in F.No.A.32018/37/2017-Ad.III A dated 01.07.2019 - Reg.

In terms of the Board's directions issued in F.No.A.32018/37/2017-Ad.III A dated 01.07.2019, a review DPC was held on 13.09.2019 to review the DPC held on 13.04.2017. The review Committee noted from the Seniority list of erstwhile Senior Tax Assistant/Executive Assistants issued on 03.04.2017, none of the Executive Assistants (erstwhile STAs re-designated as EAs) possessed the qualifying service of 05 years for promotion to the grade of Inspector on the crucial date, i.e., 01.04.2017 for the vacancy year 2017-2018 in terms of the Recruitment Rules, 2016. Therefore, all the 60 Officers empanelled for promotion to the grade of Inspector in the DPC held on 13.04.2017 were not eligible for consideration for promotion to the grade of Inspector. Therefore, the DPC decided to withdraw the Panel drawn by the DPC held on 13.04.2017.

02. Accordingly, the promotion order issued vide Order No. 36/2017 C.No: II/03/40/2017-CCA-Estt, dated 18.04.2017 is considered as withdrawn for all the officers excepting for the below mentioned 35 officers who have approached the Hon'ble High Court of Madras, vide writ petition No. 22312/2019 and WMP Nos. 21612 to 21614 & 21616/2019 which has granted interim stay of all proceedings pursuant to the proceedings dated 01.07.2019 of the Board for all the 35 petitioners mentioned hereunder:
