A review DPC was held on 30.12.2019 to review the Annual DPC 2019 for considering Shri R Ramanathan, Inspector (Emp Code 2253), for promotion to the grade of Superintendent with respect to

02. Shri R Ramanathan, Inspector, Coimbatore is hereby promoted on Regular basis to the grade of Superintendent of GST & Central Excise in the pay Matrix at the Level-8 as per 7<sup>th</sup> Pay Commission on Notional basis with effect from 01.01.2019 and on an in-situ basis. The promotion ordered now is subject to the condition that the officer join latest by 16.01.2020 failing which it will be treated that the officer has not accepted the promotion ab initio and all consequents arising as a result of not acceptance of promotion shall follow. Regular posting order will be issued later.

03. Shri R Ramanathan will be placed above Shri R Murugan (Emp Code-3822) and below Shri Venkatachari Balaji (Emp Code-6077) in the Zonal Seniority list of Superintendents.

04. The officer should exercise their option for fixation of pay in terms of F.R.221(a)(i) within one month from the date of joining as Superintendent. The officer who have already been granted Financial upgradation under Assured Career Progression Scheme / Modified Assured Career Progression Scheme are not entitled for pay fixation benefits now.

05. The promotion now ordered is subject to outcome of the followings.


- (i) Writ Petition in W.P.C.T. 261/2008 filed by Shri Samiran Roy & Others pending before the Hon'ble High Court, Calcutta in terms of Board's letter F.No.C-18012/6/2009 Ad IIB dated 16.09.2010.

- (ii) SLP pending before the Hon'ble Supreme Court against the Hon'ble A.P High Court order dated 07-03-2005 in Writ petition No. 2378/2005 filed by Shri S.S.L.Narayana and WP No. 45/2005 filed by Shri. Giridhar Prasad and others, as mentioned in the Board's letter F. No. A.32022/70/2003 AD-III A dated 26.09.2005. Therefore, the promotion of this officer to the grade of Superintendent is also subject to the outcome of above SLP.
- (iii) Other cases, if any, pending before any judicial fora.

06. Further, the Commissioner concerned shall ensure that if the Inspector whose name figuring in this promotion order is under suspension or facing any Disciplinary proceedings or prosecution or under penalty period, such officer should not be relieved or allowed to assume charge as Superintendent. This fact may be brought to the notice of the Cadre Control Authority immediately.

07. The compliance report about the joining/non-joining of the officers should be sent to this office by the concerned Commissionerate by 20.01.2020.
