- The promotion now issued is subject to the condition that the officers 2. concerned join latest by 10.01.2020, failing which it will be treated that they have not accepted the promotion ab initio and all consequences arising as a result of nonacceptance of promotion shall follow.
- Further, the Commissioners concerned shall ensure that if any of the officer whose name figuring in this promotion order is under suspension or facing any Disciplinary proceedings or prosecution or under penalty period, such officer should not be relieved or allowed to assume as Administrative Officer. This fact may be brought to the notice of the Cadre Control Authority immediately.
- The promoted officers may exercise their option for fixation of pay under FR 22(1)(a)(1) within one month from the date of receipt of this order. However, if the erstwhile Deputy Office Superintendents (re-designated as Executive Assistants) promoted have already been granted financial upgradation under Assured Career Progression Scheme / Modified Assured Career Progression Scheme, they are not entitled for any fixation benefits now.
- 5. The officers mentioned at Sl.No.1,7,8,9,12 & 13 have not completed the training for the post of Administrative Officer. As per note 3 under column 11 of the Schedule of the Administrative Officer Recruitment Rules dated 03.10.2013, they have to successfully complete the same within two years, from their promotion otherwise they will not be considered for promotion to the post of Chief Accounts Officer. Officers with less than one year of service remaining before retirement on promotion, stand exempted from training.
- Necessary compliance report about the joining /non-joining of the officers should be sent to this office by 16.01.2020.
