A Review DPC for promotion to the grade of Superintendent for the vacancy year 2002-03 was held on 12.01.2023 to implement the Order dated 24/04/2018 of the Honorable CAT Chennai in MA 310/204/2018 of OA 310/1450/2016 filed by Shri K. Gandhi & Ors, OA/310/538/2018 (Shri S. Venkatesan) and MA 235/2018 of OA/310/535/2018 (Shri S. Thangavelu & Ors) and as directed in Board's letters F.No 10C18/3/2017-AD IIB dated 19/12/2022 & 27/12/2022.

2. Consequent to the present DPC, the promotion of i) Shri K Gandhi (Emp Code-3365) (Rtd), Salem, ii) Shri S Rammohan (Emp Code-3514) (Rtd)(AC), Salem, iii) Shri R Govindan (Emp Code-1844)(Rtd), Trichy GST, iv) Shri S Venkatesan (Emp Code-2796), (Rtd) Chennai North, v) Shri A Muthu (Emp Code-3458)(Rtd) Coimbatore Audit & vi) Shri S Balasubramanian (Emp Code-3336)(Rtd) (AC), Salem, to the grade of Superintendent is reckoned with effect from 23.09.2002 on notional basis (i.e the date of promotion of their junior in general category viz Shri A Karunakar).

Further, in the Zonal Seniority list of Superintendents, i) Shri K Gandhi (Emp Code-3365), ii) Shri S Rammohan (Emp Code-3514), iii) Shri R Govindan (Emp Code-1844), iv) Shri S Venkatesan (Emp Code-2796), v) Shri A Muthu (Emp Code-3458) & vi) Shri S Balasubramanian (Emp Code-3336) will be placed below Shri J Ramesh (Emp Code-4647) and above Shri M V Mathimaran,(Emp Code-4475)

5. Further, as observed by the Hon'ble High Court, vide Interim Order dated 13.03.2017 in WMPNo.27508 and 27508/2016 filed by Shri. S. Rajagopalan & others and in W.P.No.11580/2006 filed by the department, directed (in para 24) that the notional promotion now accorded to the petitioners will be subject to the finalization of the Writ Petition Nos. 15368, 15369 of 2005, 11580 & 11581 of 2006 WP No.11580/2006 filed by the Department and the W.P.No.15368 and 15369/2006 filed by Shri.M.Jegannathan. Also, as per the Hon'ble Supreme Court Order dated 09.10.2017, no one ought to be reverted and the position of the officers belonging to reserved category who had been promoted due to implementation of own merit remains unaltered and the decision of the present DPC is subject to the final outcome of the Jarnail Singh batch of cases (in SLC (C) No.30621 of 2011
