- The promoted Officers may exercise their option for fixation of pay under FR 22(1)(a)(1) 03. within one month from the date of receipt of this order, if applicable under 7th Pay Commission. However, the officers who have been granted financial upgradation under ACP/ MACP scheme prior to the promotion to the grade of Inspector are not entitled for pay fixation.
- 04. All the Officers promoted should join on or before 23.11.2018. If they fail to join by the said date, it will be treated that they have not accepted the promotion abinitio and all consequences arising as a result of non acceptance of promotion shall follow.
- Their seniority in the grade of Inspector of Central Excise will be fixed as per the orders 05. in force.
