The officers who have already been granted financial upgradation under Assured Career Progression Scheme / Modified Assured Career Progression Scheme are not entitled for pay fixation benefits now.

04. The officers promoted on *ad hoc* basis are not entitled to exercise option for fixation of pay and the promotion does not confer on the officers so promoted any claim for continued officiation in the grade of Superintendent of GST & Central Excise and the period of such service will not be counted for seniority or as qualifying service for further promotions.

Further, the Commissioner concerned shall ensure that if the Inspector whose name figuring in this promotion order is under suspension or facing any Disciplinary proceedings or prosecution or under penalty period, such officer should not be relieved or allowed to assume charge as Superintendent. This fact may be brought to the notice of the Cadre Control Authority immediately.

07. The promotion now issued is subject to the condition that the officers concerned join latest by 05.12.2022 in their nominated place of posting failing which it will be treated that they have not accepted the promotion *ab initio* and all consequences arising as a result of non-acceptance of promotion shall follow.

08. The above officers may be transferred in the subsequent Annual General Transfer 2023 in terms of Para 10.1 of Transfer Policy 2022, for Superintendents.
