ORDER No. 164 / 2022

Sub: Notional promotion to the grade of Superintendent – Reg.

Consequent to the Review DPC held on 19.12.2022, reviewing the Annual DPC 2018, Shri Arvind Kumar (Emp Code- 7028), Inspector, Madurai GST Commissionerate is promoted to the grade of Superintendent of GST & Central Excise on regular basis in the pay Matrix at the Level - 8 as per 7th Pay Commission on notional basis with effect from 26.10.2022 i.e the date of joining this Zone on repatriation. The officer is posted to Madurai GST Commissionerate on promotion as Superintendent.

02. Shri Arvind Kumar will be placed below Shri Rajeev Kumar (Emp Code 7036) and above Shri Manoj Kumar (Emp Code 7226) in the zonal seniority list of Superintendent.

03. The officer should exercise his option for fixation of pay in terms of F.R.22 1(a) (i) within one month from the date of joining as Superintendent. The officer who has already been granted Financial upgradation under Assured Career Progression Scheme / Modified Assured Career Progression Scheme are not entitled for pay fixation benefits now.

04. The promotion now ordered is subject to outcome of the followings.

- (i) Writ Petition in W.P.C.T. 261/2008 filed by Shri Samiran Roy & Others pending before the Hon'ble High Court, Calcutta in terms of Board's letter F.No.C-18012/6/2009 Ad IIB dated 16.09.2010.
- (ii) Other cases, if any, pending before any judicial fora.

Further, the Commissioner concerned shall ensure that in case Shri Arvind Kumar, Inspector is under suspension or facing any Disciplinary proceedings or prosecution or under penalty period, the officer should not be relieved or allowed to assume charge as Superintendent. This fact may be brought to the notice of the Cadre Control Authority immediately.

06. The promotion issued is subject to the condition that the officer concerned join latest by 22.12.2022 failing which it will be treated that he has not accepted the promotion *ab initio* and all consequences arising as a result of non-acceptance of promotion shall follow.

07. The compliance report about the joining/non-joining of the officers should be sent to this office by the concerned Commissionerate by 23.12.2022.
