## ORDER NO. 79 /2019

Sub: Review DPC held on 13.09.2019 to review the DPC held on 12.05.2017 and 02.06.2017 for promotion to the grade of Erstwhile Senior Tax Assistant (Now Executive Assistant), and consequent issue of Promotion Order No. 47/2017 and Order No. 51/2017 vide C.No: II/03/42/2017-CCA-Estt, dated 12.05.2017 and 02.06.2017 - Withdrawal of Promotion orders as per Board's directions in F.No.A.32018/37/2017-Ad.III A dated 01.07.2019 - Reg.

In terms of the Board's directions issued in F.No.A.32018/37/2017-Ad.III A dated 01.07.2019, a review DPC was held on 13.09.2019 to review the DPC's held on 12.05.2017 and 02.06.2017. The review Committee noted from the Seniority list of Tax Assistant as on 01.01.2015 issued on 08.12.2015, that none of the Tax Assistants possessed the qualifying service of 10 years for promotion to the grade of Executive Assistants on the crucial date, i.e., 01.04.2016 and 01.04.2017 for the vacancy years 2016-17 and 2017-18 in terms of the Recruitment Rules, 2015. Therefore, all the 61 (60 + 01) Officers empanelled for promotion to the grade of erstwhile Senior Tax Assistants (Now Executive Assistants) in the DPC's held on 12.05.2017 and 02.06.2017 were not eligible for consideration for promotion to the grade of erstwhile Senior Tax Assistants (Now Executive Assistants). Therefore, the DPC decided to withdraw the Panel drawn by the DPC held on 12.05.2017 and 02.06.2017.

O2. Accordingly, the promotion orders issued vide Order No. 47/2017 and Order No. 51/2017 in C.No: II/03/42/2017-CCA-Estt, dated 12.05.2017 and 02.06.2017 are considered as withdrawn for all the officers **excepting** for the below mentioned **28 officers** who have approached the Hon'ble High Court of Madras, vide writ petition No. 23727/2019 and WMP Nos. 23593 & 23594/2019 which has granted interim stay of all proceedings pursuant to the proceedings dated 01.07.2019 of the Board for all the 28 petitioners mentioned hereunder:
