विषय/ Sub: Promotion to the grade of Superintendent- Reg.

Consequent upon the Annual DPC for the year 2024 held on 29.12.2023 & Review DPC held on 08.02.2024, the following Inspectors of GST & Central Excise are promoted on **Regular Basis** to the grade of Superintendent of GST & Central Excise in the pay matrix at Level-8 as per 7th Pay Commission with effect from the date shown against their names. The promotion will be effective only from the date on which the officers assume charge in the promoted grade as Superintendent in Central GST and Central Excise, Tamil Nadu & Puducherry Zone.

- O2. The officers presently posted in Tamil Nadu & Puducherry Zone and Trichy CC(P) zone are promoted on *in situ basis*. The officers on deputation basis/ Loan basis in other formations, shall repatriate back to CCA, Chennai for assuming charge as Superintendent in CCA-Estt section, Office of the Principal Chief Commissioner of GST & Central Excise, Chennai 600 034. In terms of G.I Dept. of Per & Trg; O.M No.16/7/90-Estt(Pay-I), dated the 9th September 1992 and 20th March, 1995 their controlling officers are required to relieve them immediately on receipt of this order of promotion. Their promotion will be effective only on joining this office and the delay in relieving them from deputation / loan will cause pecuniary loss to the officers.
- 03. The Seniority of the officers will be fixed as per the orders in force.
- 04. The officers promoted on Regular basis should exercise their option for fixation of pay in terms of F.R.22(I)(a)(1) within one month from the date of joining

as Superintendent. The officers who have already been granted Financial upgradation under Assured Career Progression Scheme / Modified Assured Career Progression Scheme are not entitled for pay fixation benefits now.

- 05. The promotion now ordered is subject to outcome of the followings.
 - (i) Writ Petition in W.P.C.T. 261/2008 filed by Shri Samiran Roy & Others pending before the Hon'ble High Court, Calcutta in terms of Board's letter F.No.C-18012/6/2009 Ad IIB dated 16.09.2010.
 - (ii) Jarnail Singh batch of cases in SLP (C) No.30621 of 2011 pending in Hon'ble Supreme Court of India.
 - (iii) Other cases, if any, pending before any judicial fora.
- 06. Further, the controlling officer concerned shall ensure that if the Inspector whose name is figuring in this promotion order is under suspension / undergoing Disciplinary or prosecution proceedings / is under penalty period etc, such officer should not be relieved or allowed to assume charge as Superintendent and the fact should be brought to the notice of the Cadre Control Authority immediately.
- 07. On assumption of charge as Superintendent in GST and Central Excise, Tamil Nadu & Puducherry Zone, the promoted officers will continue to work in their present place of posting until regular orders are issued.
- 08. The officers promoted shall join on the dates mentioned against their names or on the next working day if the date of promotion falls on a closed holiday, failing which it will be treated that they have not accepted the promotion *ab initio* and all consequences arising as a result of non-acceptance of promotion shall follow.
- 09. The compliance report regarding joining/non-joining of the officers on promotion to the higher grade should be sent to this office by the concerned Commissionerate within two days from the last date for joining on promotion.
- 10. This order is issued with the approval of Principal Chief Commissioner, GST & Central Excise, Tamil Nadu and Puducherry Zone.
