


ORDER NO.123 / 2024

Sub: Estt. – Promotion to the grade of Stenographer Grade-I – Regarding.

Consequent to the DPC for the year 2025 held on 26-11-2024 for the vacancy year 2025, the following Stenographer Grade-II is hereby promoted on regular basis to the grade of Stenographer Grade-I in entry pay of ₹ 35,400 /- (Index 1, Level 6 in Pay Matrix of the 7th Pay Commission) with immediate effect from 01-01-2025.

02. The officer now promoted has to repatriate back to CCA, Chennai for assuming charge as Stenographer Grade-I.

03. The above-mentioned promoted officer should join **on or after 01.01.2025 but not later than 10.01.2025** and the promotion will be effective from the date of his joining as Stenographer Grade-I. The promotion is subject to the condition that the officer joins in the promoted grade within the stipulated time, failing which it will be treated that the officer has not accepted the promotion *ab initio* and all consequences arising as a result of non-acceptance of promotion shall follow.

04. The promoted officer may exercise option for fixation of pay under FR22(1)(a)(i) within one month from the date of receipt of this order. However, if the officer has already been granted financial upgradation under Assured Career Progression Scheme/Modified Assured Career Progression prior to promotion he/she is not entitled for any fixation benefits.

05. The promotion now ordered is subject to outcome of

- W.P.C.T. No.261/2008 filed by Samiran Roy and others before the Hon'ble High Court of Calcutta in terms Board's letter F.No. C-18012/6/2009 Ad.III.B dated 16-09-2010,
- further orders that may be passed by Hon'ble Supreme Court in the said batch of cases, since the Jarnail Singh batch of cases (in SLC (C) No. 30621 of 2011).
- any other pending cases (if any), before any judicial fora.
