03. The Seniority of the promoted officers in the grade of Tax Assistant will be fixed as per the orders in force.

The officers promoted on Regular basis, mentioned at para No.1 above, should exercise their option for fixation of pay in terms of F.R.22(I)(a)(1) within one month from the date of joining as Tax Assistant. The officers who have already been granted Financial upgradation under Assured Career Progression Scheme / Modified Assured Career Progression Scheme are not entitled for pay fixation benefits now.

The officers promoted on Adhoc basis, mentioned at Para No.2, above, are not entitled to exercise option for fixation of pay and the promotion does not confer on the officers, so promoted, any claim for continued officiation in the grade of Tax Assistant of GST & Central Excise and the period of such service will not be counted for seniority or as qualifying service for further promotions.
