03. The Seniority of the officers will be fixed as per the orders in force.
04. The officers promoted on Regular basis, mentioned at para No.1 above, should exercise their option for fixation of pay in terms of F.R.22(I)(a)(1) within one month from the date of joining as Superintendent. The officers who have already been granted Financial upgradation under Assured Career Progression Scheme / Modified Assured Career Progression Scheme are not entitled for pay fixation benefits now.
05. The officers promoted on Adhoc basis, mentioned at Para No.2 above, are not entitled to exercise option for fixation of pay and the promotion does not confer on the officers, so promoted, any claim for continued officiation in the grade of Superintendent of GST & Central Excise and the period of such service will not be counted for seniority or as qualifying service for further promotions.
06. The promotion now ordered is subject to outcome of the followings.

  - (iii) Other cases, if any, pending before any judicial fora.
07. Further, the Commissioner concerned shall ensure that if the Inspector whose name figuring in this promotion order is under suspension or facing any Disciplinary proceedings or prosecution or under penalty period, such officer should not be relieved or allowed to assume charge as Superintendent. This fact may be brought to the notice of the Cadre Control Authority immediately.
08. The promotion now issued is subject to the condition that the officers concerned join latest by 20.11.2023 in their nominated place of posting failing which it will be treated that they have not accepted the promotion *ab initio* and all consequences arising as a result of non-acceptance of promotion shall follow.
09. The compliance report about the joining/non-joining of the officers should be sent to this office by the concerned Commissionerate by 22.11.2023.

10. The representations of the officers if any requesting transfer / retention will not be considered until they join in their nominated place of posting on promotion. Further, the request for proforma promotion / Loan basis posting will not be considered.
