Sub: Assured Career Progression Scheme - Grant of First Financial upgradation to Inspector completing 12 years of regular service – Reg

Shri D Jeyachandrapandi (Emp Code-4353), Inspector of Central Excise (now Superintendent), Trichy Customs is granted first financial upgradation to the grade of Superintendent in the Pay scale of Rs.6500-200-10500 with effect from 12.10.2002. The details are given below.

2. The Financial upgradation is subject to the following grounds:-

a) The Service Book of the officer should be verified and ensured that the officer has joined the post of Inspector as a Direct Recruit in the Forenoon on the date indicated against his name in Column (4) of the above Table and no break-in-service is ignored while computing the continuous regular service of 12 years from the date of joining as Direct Recruit Inspector. Discrepancy found, if any, may please be reported to this office along with documentary evidence for making good the records maintained in this office.

- b) The other conditions outlined in Annexure I of the DOPT O.M. NO.35034/1/97-Est(D) dated 09.08.1999 should be strictly complied with.
- c) His pay shall be fixed under the provisions of FR 22 (I) (a) (1) with effect from the date of granting of financial upgradation. On financial upgradation under ACP Scheme, the Government servant has an option under F.R. 22(I) (a)(1) to get his pay fixed in the higher post either from the date of his financial upgradation or from the date of his next increment.
- d) The financial benefit allowed under the ACP scheme shall be final and no pay fixation benefit shall accrue at the time of regular promotion i.e posting against a functional post in the higher grade. Hence, the above officer is permitted to exercise option for fixation of pay under F.R.22(1)a(1) within one month from the date of receipt of this order.
