- 02. The officers now promoted have to repatriate back to CCA, Chennai for assuming charge as Senior Private Secretary.
- 03. The Seniority of the promoted officers in the grade of Senior Private Secretary will be fixed as per the orders in force.
- 04. The officers promoted on Regular basis, should exercise their option for fixation of pay in terms of F.R.22(I)(a)(1) within one month from the date of joining as Senior Private Secretary. The officers who have already been granted financial upgradation under Assured Career Progression Scheme / Modified Assured Career Progression Scheme are not entitled for pay fixation benefits now.

- 05. The promotion now ordered is subject to outcome of the followings:

 - ii. Jarnail Singh and Ors. V. Lachhmi Narain Gupta and Ors. (Civil Appeal No.629 of 2022 arising out of SLC (C) No.30621 of 2011) and batch in SLP© NO.30621 of 2011 pending in Hon'ble Supreme Court of India.
 - iii. Other cases, if any, pending before any judicial fora.

The promotion order now issued is subject to the condition that the officers concerned join latest by 31.07.2024 in their present place of posting failing which it will be treated that they have not accepted the promotion ab initio and all consequences arising as a result of non-acceptance of promotion shall follow.
