**ORDER NO.65 / 2024****Sub: Promotion to the grade of Senior Private Secretary - Reg**

Consequent to the Annual DPC for the Year 2024 held on 23.07.24, the following Private Secretary are hereby promoted on regular basis to the grade of Senior Private Secretary (Group 'B' Gazetted) in - in the Pay Matrix of 7<sup>th</sup> Pay Commission on an in situ basis until further orders. The promotion order will be effective from the date of assumption of charge as Senior Private Secretary:

02. The officers now promoted have to repatriate back to CCA, Chennai for assuming charge as Senior Private Secretary.

03. The Seniority of the promoted officers in the grade of Senior Private Secretary will be fixed as per the orders in force.

04. The officers promoted on Regular basis, should exercise their option for fixation of pay in terms of F.R.22(I)(a)(1) within one month from the date of joining as Senior Private Secretary. The officers who have already been granted financial upgradation under Assured Career Progression Scheme / Modified Assured Career Progression Scheme are not entitled for pay fixation benefits now.

05. The promotion now ordered is subject to outcome of the followings:

- iii. Other cases, if any, pending before any judicial fora.

The promotion order now issued is subject to the condition that the officers concerned join latest by 31.07.2024 in their present place of posting failing which it will be treated that they have not accepted the promotion ab initio and all consequences arising as a result of non-acceptance of promotion shall follow.
