02. All the promoted officers should join **immediately** but not later than 15.06.2023. If the officers mentioned above fail to join by the said date, it will be treated that they have not accepted the promotion ab initio and all consequences arising as a result of non-acceptance of promotion shall follow.

03. The promoted Officers working on deputation basis should repatriate back to Chennai Zone and assume charge as Executive Assistant in CCA-Estt Section, office of the Principal Chief Commissioner of GST & Central Excise, Chennai-34. Their promotion as Executive Assistant will be effective only on joining this office.

04. All the promoted officers would be considered for deployment as per the AGT 2022 Transfer Policy.

05. The promoted officers may exercise their option for fixation of pay under FR 22(1)(a) (i) within one month from the date of receipt of this order. However, if the officer has been granted financial upgradation under ACP / MACP scheme prior to promotion he is not entitled for any pay fixation benefits now.
06. The Seniority of the promoted officers in the grade of Executive Assistant will be fixed as per the orders in force.
07. The promotion now ordered is subject to outcome of the following:
- (i) W.P.C.T.No.261/2008 filed by Samiran Roy and others before the Hon'ble High Court of Calcutta in terms of Board's letter F.No.C-18012/6/2009.Ad.III.B dated 16.09.2010,
- (ii) further orders that may be passed by the Hon'ble Supreme Court of India in the said batch of cases, since the Jarnail Singh batch of cases in SLC(C) No.30621 of 2011 is pending.
- (iii) any other pending cases, before any judicial fora.
08. Necessary compliance report regarding their joining should be sent to this office by 16.06.2023.
