विषय / Sub: Promotion to the grade of Superintendent- Reg.

Consequent upon the Annual DPC for the year 2024 held on 29.12.2023 and Review DPC held on 08.02.2024, the following Inspector of GST & Central Excise is promoted on Regular Basis to the grade of Superintendent of GST & Central Excise in the pay Matrix at Level-8 as per 7<sup>th</sup> Pay Commission with effect from the date shown against his name. The promotion now ordered will be effective from the date on which the promoted officer assume charge as Superintendent in Central GST and Central Excise, Tamil Nadu & Puducherry Zone.

02. The officer on Deputation basis, has to immediately repatriate back to CCA, Chennai for assuming charge as Superintendent in CCA-Estt section, Office of the Principal Chief Commissioner of GST & Central Excise, Chennai 600 034. In terms of G.I Dept. of Per & Trg; O.M No.16/7/90-Estt(Pay-I), dated the 9<sup>th</sup> September 1992 and 20<sup>th</sup> March, 1995 his controlling officers are required to relieve him immediately on receipt of this order of promotion. The promotion will be effective only on joining this office and the delay in relieving him from deputation / loan will cause the officer pecuniary loss.

03. The Seniority of the officer will be fixed as per the orders in force.

04. The officer promoted on Regular basis should exercise option for fixation of pay in terms of F.R.22(I)(a)(1) within one month from the date of joining as Superintendent. The officers who have already been granted Financial upgradation under Assured Career Progression Scheme / Modified Assured Career Progression Scheme are not entitled for pay fixation benefits now.

05. The promotion now ordered is subject to outcome of the followings.

(iii) Other cases, if any, pending before any judicial fora.


06. Further, the controlling officer concerned shall ensure that if the Inspector whose name is figuring in this promotion order is under suspension / undergoing Disciplinary or prosecution proceedings / is under penalty period etc, such officer should not be relieved or allowed to assume charge as Superintendent and the fact should be brought to the notice of the Cadre Control Authority immediately.

07. On assumption of charge as Superintendent in Central GST and Central Excise, Tamil Nadu & Puducherry Zone, the promoted officer will continue to work in his present place of posting until regular posting orders are issued.

08. The promotion now issued is subject to the condition that the officer concerned shall assume charge as Superintendent in Central GST and Central Excise, Tamil Nadu & Puducherry Zone within 10 days from his date of promotion. If an officer does not want to accept the promotion, he may make a written request and if the reasons adduced for refusal of promotion are acceptable to the Appointing Authority, the request will be considered by the Appointing Authority, taking relevant aspects into consideration..

09. The compliance report about the joining/non-joining of the officers on promotion to the higher grade should be sent to this office by the concerned Commissionerate within two days from the last date for joining on promotion.
