02. The officers presently posted in Tamilnadu & Puducherry CGST Zone and Trichy CC(P) zone are promoted <u>on in situ basis</u>. The officers on Deputation basis / Loan basis in other formations, have to repatriate back to CCA, Chennai for assuming charge as Superintendent in CCA-Estt section, Office of the Principal Chief Commissioner of GST & Central Excise, Chennai 600 034. In terms of G.I Dept. of Per & Trg; O.M No.16/7/90-Estt(Pay-I), dated the 9<sup>th</sup> September 1992 and 20<sup>th</sup> March, 1995 their controlling officers are required to relieve them immediately on receipt of this order of promotion. Their promotion will be effective only on joining this office and the delay in relieving them from deputation / loan will cause the officer pecuniary loss.

03. The Seniority of the officers will be fixed as per the orders in force.

04. The officers promoted on Regular basis should exercise their option for fixation of pay in terms of F.R.22(I)(a)(1) within one month from the date of joining as Superintendent. The officers who have already been granted Financial upgradation under Assured Career Progression Scheme / Modified Assured Career Progression Scheme are not entitled for pay fixation benefits now.

05. The promotion now ordered is subject to outcome of the following.

(i) Writ Petition in W.P.C.T. 261/2008 filed by Shri Samiran Roy & Others pending before the Hon'ble High Court, Calcutta in terms of Board's letter F.No.C-18012/6/2009 Ad IIB dated 16.09.2010.

(ii) Jarnail Singh batch of cases in SLP (C) No.30621 of 2011 pending in Hon'ble Supreme Court of India.

(iii) Other cases, if any, pending before any judicial fora.

06. Further, the respective controlling officers concerned shall ensure that if the Inspector whose name is figuring in this promotion order is under suspension / undergoing disciplinary or prosecution proceedings / is under penalty period etc, such officer should not be relieved or allowed to assume charge as Superintendent and the fact should be brought to the notice of the Cadre Control Authority immediately.

07. On assumption of charge as Superintendent in GST and Central Excise, Tamil Nadu & Puducherry Zone, the promoted officers will continue to work in their present place of posting until regular posting orders are issued.

08. The officers who are promoted shall assume charge as Superintendent in GST and Central Excise, Tamil Nadu & Puducherry Zone within 10 days from their date of promotion or within 10 days from their date of relieving (for officers who are currently posted outside GST and Central Excise, Tamil Nadu & Puducherry Zone).

09. The compliance report about the joining/non-joining of the officers on promotion to the higher grade should be sent to this office by the concerned Commissionerate within two days from the last date for joining on promotion.

10. This order is issued with the approval of Principal Chief Commissioner, GST & Central Excise, Tamil Nadu and Puducherry Zone.
