Please find enclosed herewith copy of Vacancy Circulars issued by the GST
Hyderabad GST Commissionerate vide C.No.II/3/8/2021-Estt (CCA) dated 28.04.2021,
on the above-mentioned subject.

2. Hyderabad GST Commissionerate proposes to draw a panel of
Superintendents/Inspectors of Central tax and Superintendent/Preventive officers of
Customs Houses for posting as ACS/ACO, in the Rajiv Gandhi International Airport,
Hyderabad against 25% quota vacancies meant for outside customs House/CGST
Commissionerate. Vacancies earmarked are as given hereunder.

Name of the Post	Vacancies under 25% quota
Air Customs Superintendent (ACS)	8
Air Customs Officers (ACO)	12

**The above vacancies are for all Zones in the country put together and no
specific number is earmarked for any particular Zone.**

3. The guidelines, terms and conditions will be as contained in the Air pool policy issued vide Board's letter dt. 21.10.1993, 22.10.2008 and 15.02.2019. The period of posting at Airport is initially for two years and it may be extended by one more year, subject to the willingness of the officer and its acceptance by the Chief Commissioner, Customs and Central Tax, Hyderabad Zone.

4. The other eligible criteria's are mentioned at para No.4 of the vacancy circular.

5. Accordingly, the willingness if any, from the eligible officers for the post of Air Customs superintendent and Air Customs officers for deputation to Rajiv Gandhi International Airport, Hyderabad, along with Bio data and history of postings of the Officer in duplicate, duly authenticated by the Administrative officer in charge of service book section may be forwarded to this Office **on or before 25.06.2021.**

6. The ACR gradings for the last five years duly verified and attested by the Additional/Joint commissioner (P&V) along with vigilance clearance certificate of the Officers may also be forwarded. It may also be ensured that the officers are free from Vigilance/Non-Vigilance cases.

7. The Officers who have already applied for the said deputation, need not apply again.

8. This circular is issued with the approval of the Pr. Chief Commissioner of GST and Central Excise, Chennai Zone.
