Commissioner of Customs, Chennai VIII Commissionerate, has issued two vacancy Circulars in F.No: S14/25/221-ESTT and F.No: S14/26/221-ESTT dated 03.03.2021 , intimating vacancies under the 25 % quota on deputation basis to the posts of Air Customs Superintendent/ Air Customs Officer at Chennai Anna International Airport .

02. Accordingly, the willingness if any, from the eligible officers for the post of Air Customs Superintendent and Air Customs Officers for deputation to Chennai Anna International Airport , along with Bio Data and history of postings of the Officer in duplicate, duly authenticated by the Administrative officer in charge of Service Book section may be forwarded to this Office **on or before 23.03.2021** .

03. The ACR gradings for the last five years duly verified and attested by the Additional /Joint Commissioner (P&V) along with Vigilance Clearance certificate of the Officers may also be forwarded.

04. Since this circular is in continuation to this Office Circular on the same subject issued in file C.No: II/13/05/2020-CCA-Estt, dated 15.12.2020, the Officers who have already applied for the said deputations need not apply again.

05. It is informed that applications complete in all respects (including ACR gradings) , will only be considered. It may be noted that applications received in this office after the due date ie 23.03.2021 will not be considered.

06. This circular is issued with the approval of the Principal Chief Commissioner of GST and Central Excise, Tamil Nadu and Puducherry Zone.
