

**MINUTES OF THE MEETING HELD ON 04.08.2021 BETWEEN THE CHIEF COMMISSIONER OF CUSTOMS, CHENNAI & CHENNAI GST ZONE AND THE CHIEF COMMISSIONER OF CUSTOMS (PREVENTIVE ZONE), TRICHY FOR POSTING OF DEPUTY/ ASSISTANT COMMISSIONERS AMONG GST ZONE, TAMILNADU & PUDUCHERY, CUSTOMS ZONE, CHENNAI AND CCP ZONE TRICHY**

With reference to the Board Order No. 82/2021 dated 15.07.2021 and Order No. 85/2021 dated 19.07.2021 wherein 27 officers are posted to the Chennai GST Zone, Board has instructed for sharing of the officers with Chennai Customs Zone and Trichy Customs (preventive) Zone. For that purpose, a virtual meeting was held on 04.08.2021. Dr. Uma Shanker, Chief Commissioner of Customs (Preventive) Zone, Trichy and Shri M.V.S Choudary, Chief Commissioner of Customs, Chennai Zone & Chennai GST Zone have attended the meeting for the postings of Assistant / Deputy Commissioners among GST Zone, Chennai, Customs Zone, Chennai and CCP Zone Trichy.

02. The following points were considered for the posting of Assistant Commissioner / Deputy Commissioners in the three zones.

a) The Officers who are opting for CCP Trichy Zone may be posted to CCP Trichy Zone.

b) Remaining Officers may be given posting based on their representations, vacancy position, their history of postings and administrative needs.

3. The present vacancy position in respect of Chennai GST Zone, Chennai Customs Zone and CCP Trichy Zone, as detailed below, was discussed.




4. It has been decided to maintain near equal vacancy percentage in the three zones and accordingly, the number of officers is distributed as mentioned below.
