05. The promoted Havaldars may exercise their option for fixation of pay under FR 22(1)(a)(i) within one month from the date of receipt of this Order. However, if the officer has been granted financial up-gradation under

ACP/MACP scheme prior to promotion he/she is not entitled for any pay fixation benefits now.

06. The seniority of the promoted Havaldars in the grade of Lower Division Clerk will be fixed as per the orders in force.

07. Necessary compliance report regarding their joining should be sent by 14.10.2021.
