ORDER NO. 119/2021

Sub: Review DPC held on 13.09.2019 to review the DPC held on 13.04.2017 for Promotion to the grade of Inspector, and consequent issue of Promotion Order No. 36/2017 vide C.No: II/03/40/2017-CCA-Estt, dated 18.04.2017 – Withdrawal of Promotion orders as per Board's directions issued in F.No.A.32018/37/2017-Ad.III A dated 01.07.2019 - Reg.

This office is in receipt of letter dated 02.11.2021 from Shri. J. Dilip Kumar, Inspector of GST & Central Excise enclosing Order Sheet 2 of MA /100/2169/2021 of Hon'ble CAT Principal Bench , New Delhi, ordering the withdrawal and deletion of his name as petitioner from the OA/100/1827/2021.

- O2. Shri. J. Dilip Kumar, one of the petitioners in the WP No. 22312/2019 and OA No. 975/2019 (Renumbered as 1827/2021 on transferring of the case from Hon'ble CAT Madras Bench to Hon'ble CAT, Principal Bench, New Delhi) had approached the Hon'ble High Court, Madras and obtained stay of all further proceedings pursuant to the proceedings dated 01.07.2019 of Board.
- 03. The Hon'ble High Court of Madras vide common order dated 4.08.2020 passed in WP Nos. 22312,23727,21847 and 21858 of 2019 had stated that the interim order granted by High Court Madras are made absolute and that they would continue till the disposal of the OA. All the OA's which were otherwise pending before the CAT Chennai Bench were directed to be transferred and posted along with pending matters before the Hon'ble CAT Principal Bench Chennai. It was also stated in the common order that with the above directions, the Writ petitions stand disposed off.

- 4. As mentioned in Para 1, since the name of Shri. J. Dilip Kumar, Inspector has been withdrawn from the OA. the promotion of Shri. J. Dileep Kumar issued vide Order No. 36/2017 dated 18.04.2017 stands withdrawn with effect from 01.10.2019.
- 05. Upon withdrawal of the promotion, the officer will continue to draw the same pay as drawn before prior to promotion in the lower post i.e. Executive Assistant (erstwhile Senior tax Assistant) and the seniority would be same as existed earlier in the lower post.
- 06. Compliance report of this order may be sent to this office on or before 03.12.2021 along with copy of the re-fixation order.
