Consequent to the DPC held on 22.12.2021, reviewing the Annual DPC for the vacancy year 2021, the following Executive Assistant is hereby promoted on regular basis to the grade of Administrative Officer (Group-B Gazetted) in the pay matrix at the Level-7 (Rs.9300-34800 with corresponding Grade Pay of Rs.4600/- in 6<sup>th</sup> Pay Commission) as per 7<sup>th</sup> Pay Commission recommendation, on notional basis with effect from 18.12.2021. The officer shall assume charge as Administrative Officer on or before 07.01.2022 and the promotion will be effective from the date of her joining as Administrative Officer of GST and Central Excise.

- 2. The Seniority of the Officer in the grade of Administrative Officer will be fixed below Smt.J.Sakthiya (Emp code-7471).
- 3. The officer should exercise the option for fixation of pay in terms of FR 22(1)(a)(1) within one month from the date of joining as Administrative Officer. If the officer has already been granted Financial upgradation under Assured Career Progression Scheme/ Modified Assured Career Progression Scheme, she is not entitled for pay fixation benefits now. The pay shall be fixed with effect from the notional date and arrears of Pay and Allowances will be payable from the date actual assumption of charge as Administrative Officer in terms of FR 17.
- 4. The effective date of promotion of the newly promoted officer is 18.12.2021

since the officer completed the training for promotion to the grade of Administrative Officer on 17.12.2021, and also that the officer cannot claim any stepping up of pay in terms of 3(b) and (d) of DoPT O.M.No.4/3/2017-Estt.(Pay-I) dated 26.10.2018.

- 5. Further, the Principal Commissioner concerned shall ensure that if the officer is under suspension or facing any Disciplinary proceedings or prosecution or under penalty period, she should not be allowed to assume as Administrative Officer. This fact may be brought to the notice of the Cadre Control Authority immediately.
- 6. The promotion now issued is subject to the condition that the officer concerned join latest by 07.01.2022 in her nominated place of posting, failing which it will be treated that she has not accepted the promotion *ab initio* and all consequences arising as a result of non-acceptance of promotion shall follow.
- 7. Further, the following Posting and Transfer in the grade of Administrative Officer is also ordered with immediate effect.
