While reporting, the candidates are required to submit the duly filled in Attestation forms available on Chennai Commissionerate website <a href="http://www.centralexcisechennai.gov.in/">http://www.centralexcisechennai.gov.in/</a> in <a href="http://www.centralexcisechennai.gov.in/">Three sets</a> without fail along with original certificates in proof of:

- a) Date of Birth
- b) Educational Qualifications
- c) Community Certificate, if applicable
- d) PH/ Ex- Serviceman Certificate, if applicable
- e) Aadhaar Card and Pan Card
- f) Any other relevant document (which the candidate feels necessary)
- 3. The candidates are required to bring the attestation forms along with the Identity certificate and Character certificate duly attested from three different Gazetted Officers who have known the candidate for a minimum of two years. Available on Chennai Commissionerate website <a href="http://www.centralexcisechennai.gov.in/">http://www.centralexcisechennai.gov.in/</a>
- 4. The candidates are also required to undergo the prescribed medical examination. Hence, they are hereby directed to produce the "Medical Certificate of fitness on first entry into Government Service" in the enclosed Performa, obtained from a Medical Officer not below the rank of Civil Surgeon at their own cost.

- 6. Also, if the candidate has been issued with any Show Cause Notice (SCN), the reply of SCN along with proof of having sent the reply to the SSC should be brought at the time of verification without fail.
- 7. No travelling or other expenses will be paid by the Department for attending Certificate verification. It may be noted that the candidates have to make their own arrangements for boarding and lodging during the stay.
- 8. As per DOPT's instructions, physically handicapped candidates have to submit a Disability Certificate issued by the competent authority in the prescribed format. The competent authority for issue of the Disability Certificate shall be a Medical board duly constituted by the Central or State Government. Certificate not conforming to the prescribed format will not be accepted.
- 9. It may please be noted that any request from the candidates for rescheduling of dates will **n**ot be entertained.
- 10. In the event of not reporting on the prescribed date for the Document Verification, it will be presumed that you are not interested in accepting the offer of appointment in the department and your nomination will be treated as cancelled and the dossier will be returned to SSC.
