The Departmental Promotion Committee (DPC) meeting for Confirmation in the grade of Inspectors was held on 04.11.2022 and 173 Inspectors were empanelled for confirmation. However, the DPC has decided that the orders of confirmation may be issued after the fulfilment of all the conditions stipulated in the offer of appointment viz. physical test, medical examination, verification of character and antecedents, verification of original certificates regarding date of birth, educational qualifications, caste certificate, disability certificate and any other relevant documents, before issue of the confirmation orders.

2. The verification of genuineness of caste certificate and/ or education qualification is /are pending for 74 officers against whom the same has been mentioned in the remarks column in the Annexures enclosed. Hence, the confirmation orders for these officers may be issued only after the verification of genuineness of caste certificate and / or educational qualification is completed.
