

MINUTES OF THE MEETING HELD ON 29.07.2021 AMONG THE PRINCIPAL CHIEF COMMISSIONER OF GST & CENTRAL EXCISE, TAMILNADU & PUDUCHERRY, THE CHIEF COMMISSIONER OF CUSTOMS, CHENNAI AND THE CHIEF COMMISSIONER OF CUSTOMS (PREVENTIVE ZONE), TRICHY FOR POSTING OF ADDITIONAL COMMISSIONER /JOINT COMMISSIONER AMONG GST ZONE, TAMILNADU & PUDUCHERY, CUSTOMS ZONE, CHENNAI AND CCP ZONE TRICHY

With reference to the Board Order No. 82/2021 dated 15.07.2021 and Order No. 84/2021 dated 19.07.2021 wherein 17 officers are posted to the Chennai GST Zone, the Board has instructed for sharing of the officers with Chennai Customs Zone and Trichy Customs (preventive) Zone. For that purpose, a meeting was held on 29.07.2021. Shri G.V Krishna Rao, Principal Chief Commissioner of GST & Central Excise, Chennai, Dr. Uma Shankar, Chief Commissioner of Customs (Preventive) Zone, Trichy (joined through virtual mode) and Shri M V S Choudary, Chief Commissioner of Customs, Chennai Zone have attended the meeting in the GST Bhavan, Chennai for posting of Additional / Joint Commissioners among GST Zone, Chennai, Customs Zone, Chennai and CCP Zone Trichy.

2. The following points were considered for the posting of Additional Commissioner / Joint Commissioners in the three zones.

a) The officers, who have never worked in Customs or have minimum period of working in Customs may be posted to Chennai Customs Zone.

b) The Officers who are opting for CCP Trichy Zone may be posted to CCP Trichy Zone.

c) Remaining Officers may be given posting based on their history of postings, representations, vacancy position and administrative needs.

3. The present vacancy position in respect of Chennai GST Zone, Chennai Customs Zone and CCP Trichy Zone, is detailed below.


4. It has been decided to allocate the number of officers as follows in the three Zones.


