

MINUTES OF THE MEETING OF THE PRINCIPAL CHIEF COMMISSIONER OF GST & CENTRAL EXCISE, CHENNAI AND THE CHIEF COMMISSIONER OF CUSTOMS, CHENNAI HELD ON 29-07-2021, TO ROTATE ADDITIONAL / JOINT COMMISSIONERS BETWEEN GST ZONE, TAMILDADU & PUDUCHERRY AND CUSTOMS ZONE, CHENNAI.

As per Para 3.2.1 and 3.2.2 of the transfer/placement guidelines, 2018 for Group "A" Officers of the Indian Revenue Service (C&CE), the Officers will, as far as possible, be rotated between the Customs and GST branches every 2-3 years. At stations where there are separate Principal Chief Commissioners/ Chief Commissioners of Customs and GST, a Committee of all such Chief Commissioners shall collectively decide on the rotation between Customs and GST & CX Zones. Normally, this shall be done after the Annual General Transfers have been effected.

02. In view of the above, a Meeting was held on 29-07-2021 at between Shri. G.V. Krishna Rao, Chief Commissioner of GST & Central Excise, Chennai and Shri. M.V.S. Choudary, Chief Commissioner of Customs, Chennai for rotation of Additional / Joint Commissioner between Customs and GST & Central Excise Zones.

03. The following criteria were adopted for deciding the rotation of the officers.

- i. Officers who have completed a continuous tenure of TWO years and more as on 01.07.2021 in Chennai GST Zone and Chennai Customs Zone are listed out in the charts prepared and the officers with longer tenure are considered for rotation.
- ii. Those officers who are working outside Chennai City are not considered for posting due to present pandemic situation.
- iii. The tenure of period worked in Directorates immediately before joining GST Zone is also considered for rotation to Customs.
- iv. Officers of 2002 batch are not considered due to their seniority and expected promotion as Commissioner soon.

- v. It is decided to balance the vacancy positions in both the zones, in the grade of JC/ADC.

04. After sharing of officers posted vide Board Order No. 82/2021 dated 15.07.2021 and Order No. 84/2021 dated 19.07.2021 among Chennai GST Zone, Chennai Customs Zone and CCP Zone, Trichy, the sanctioned strength, working strength and vacancy position in the grade of ADC/ JC in both Zones is as follows:-




06. The charts prepared and duly certified by ADC/JC of CCO, Chennai GST Zone and Chennai Customs Zone based on the continuous tenure of officers in their respective zones have been perused. Considering the vacancy position on both the sides, it has been decided to transfer 02 ADC/JCs from Chennai Customs Zone to Chennai GST & CX Zone and 02 ADC/JCs from Chennai GST & CX Zone to Chennai Customs Zone in the order of their continuous present tenure seniority in the zone. To ensure effective implementation and continuity in coordination with CPWD for the infrastructure projects at Anna Nagar and Nungambakkam where 90 Crores have been sanctioned by the Board for the current financial year and since the Principal Commissioner incharge of the said project has been transferred, Chief Commissioner, Chennai Customs Zone requested to retain Shri. T. Samaya Murali, ADC on Administrative grounds. After these transfers the percentage of vacancy in Chennai GST Zone will be 14.71% and that of Chennai Customs Zone will be 22.73%.

07. Based on the above and the discussions, it was decided to rotate/transfer Officers from GST & Central Excise Zone to Chennai Customs Zone and vice-versa as follows: -
