ORDER NO. 174/ 2022Sub: Estt-Promotion to the grade of Assistant Sub Inspector (Weapons) - Reg.

Consequent to the Annual DPC held on 30.12.2022 for the vacancy year 2023, the following Head Havaldar is hereby promoted on regular basis to the grade of Assistant Sub Inspector (Weapons) in the entry pay of ₹ 21,700/- (Level:3 Index:1 in the Pay Matrix of 7th Pay Commission) with effect from the date of assumption charge of the post, not before 01.01.2023 and posted on in-situ basis until further orders.

2. The Head Havaldar promoted should join on or after **01.01.2023**. The promotion is subject to the condition that the officer join in the promoted cadre not later than **13.01.2023** failing which it will be treated that the officer has not accepted the promotion ab initio and all consequences arising as a result of non-acceptance of promotion shall follow.

3. The seniority of the Assistant Sub Inspector (Weapons) will be fixed as per the orders in force.

4. The promoted officer should exercise their option for fixation of pay in terms of F.R.22 I(a) (i) within one month from the date of joining as Assistant Sub Inspector (Weapons). If he has already been granted financial upgradation under Assured Career Progression Scheme/Modified Assured Career Progression Scheme he is not entitled for pay fixation benefits now.

5. Necessary compliance report regarding their joining should be sent by 20.01.2023.

6. The promotion now ordered is subject to outcome of the following:
