02. All the Havaldars promoted should join **on or after 01.01.2023** but not later than 13.01.2023. If the Havaldars mentioned above fail to join by the said date, it will be treated that they have not accepted the promotion ab initio and all consequences arising as a result of non-acceptance of promotion shall follow.

03. All officers are posted at the same formation. They would be considered for deployment as per the transfer policy during AGT-2023.

04. The promoted officers may exercise their option for fixation of pay under FR 22(1)(a) (i) within one month from the date of receipt of this order. However, if the officer has been granted financial up gradation under ACP/MACP scheme prior to promotion he is not entitled for any pay fixation benefits now.

05. The Seniority of the promoted officers in the grade of Lower Division Clerk will be fixed as per the orders in force.

06. The promotion now ordered is subject to outcome of the following:
