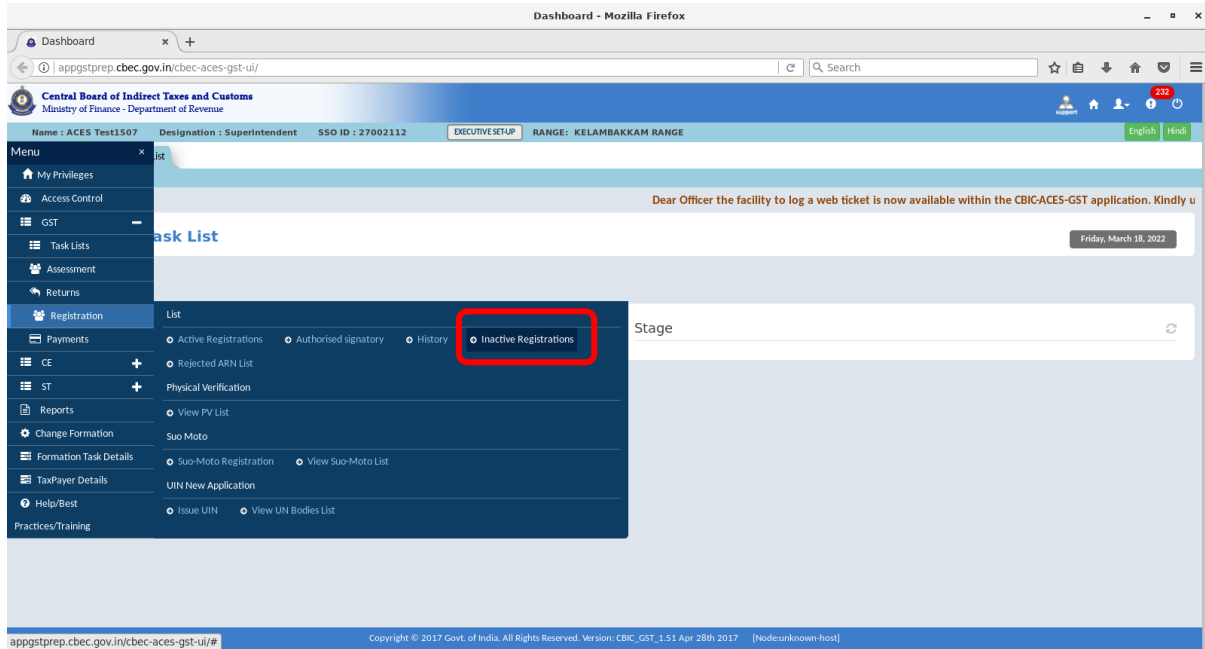


## Restoration of Cancelled Registrations based on Appellate order

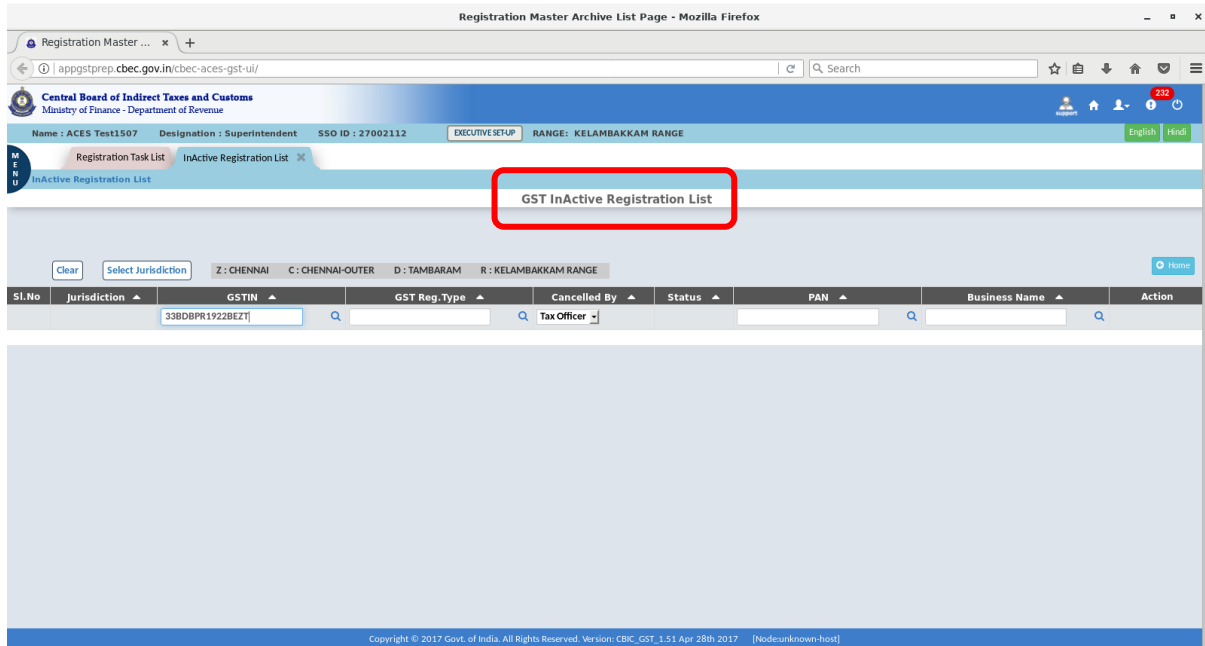

Step by step guide to use the functionality is as under:

1. Range officer to Login and Select Menu- Registration-Inactive Registrations as shown below.



2. Click on the Inactive Registration referred above displays the GST Inactive Registration list as below.



- Enter the GSTIN to be restored in the GSTIN search box and click on search icon. GSTIN details is displayed as below.

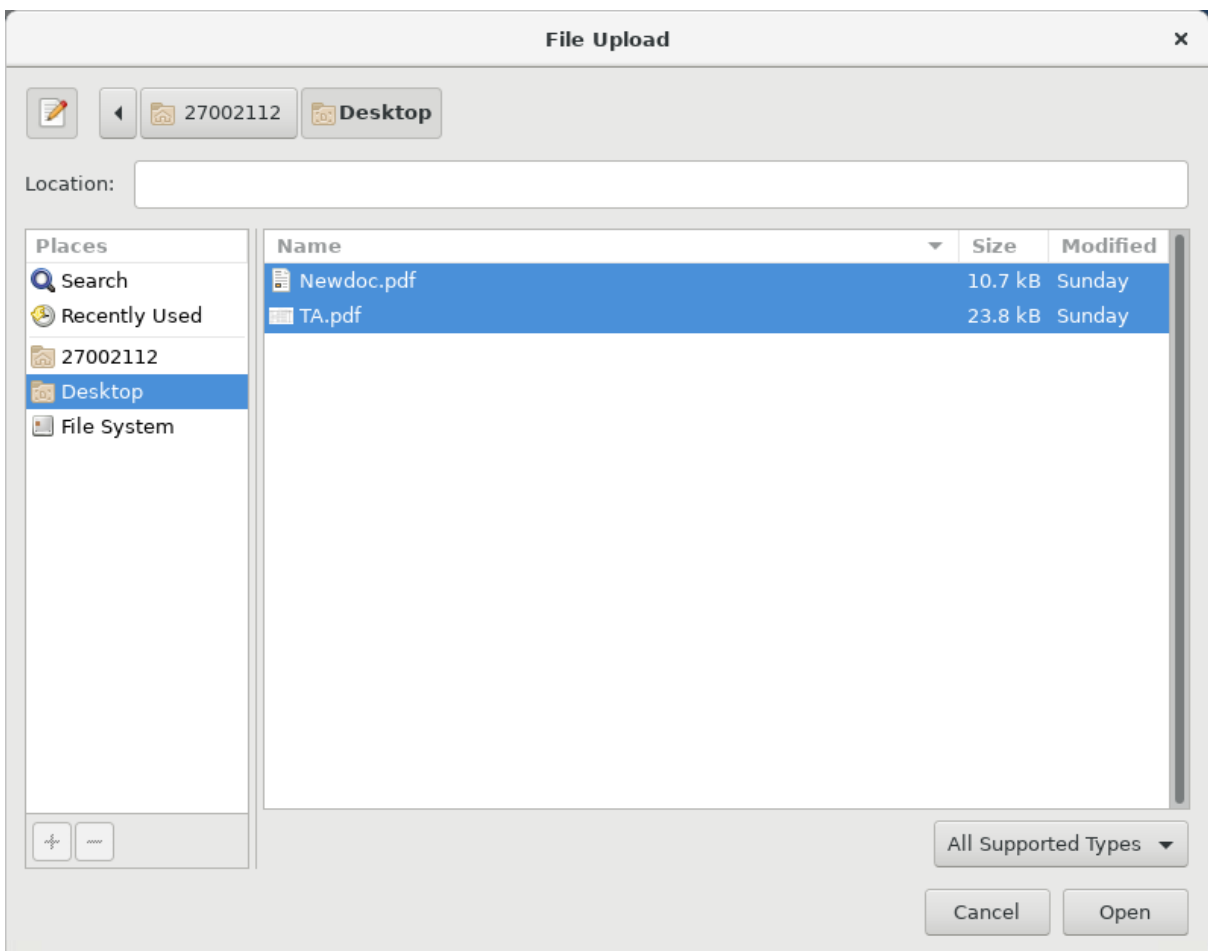
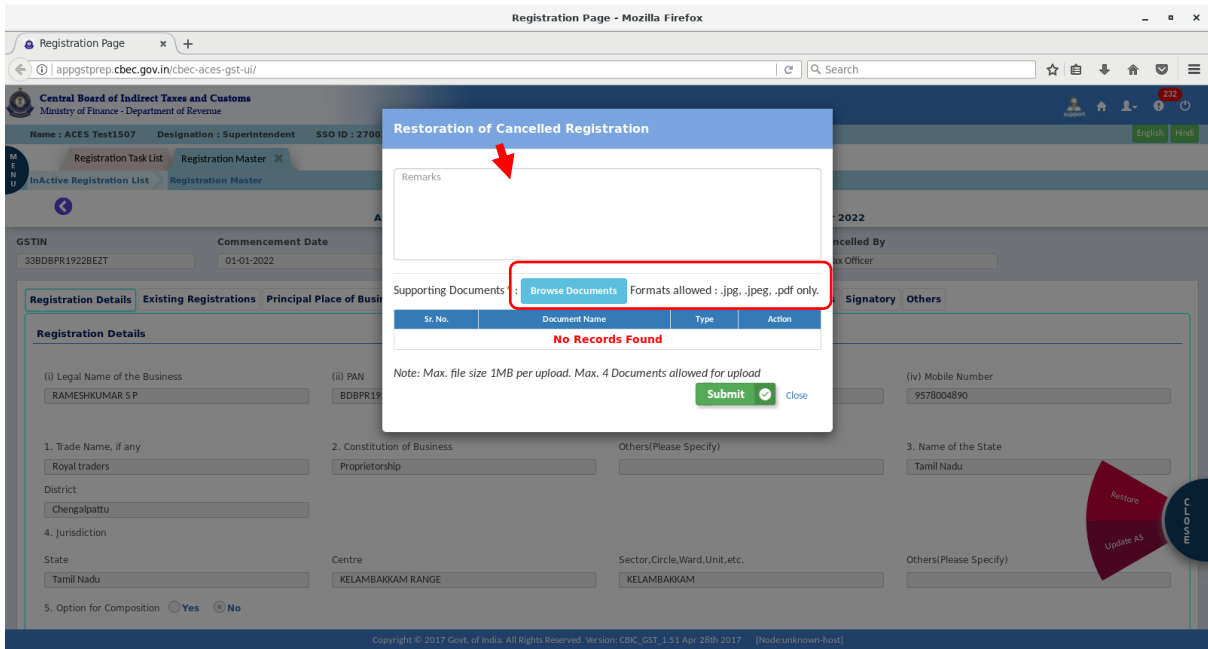

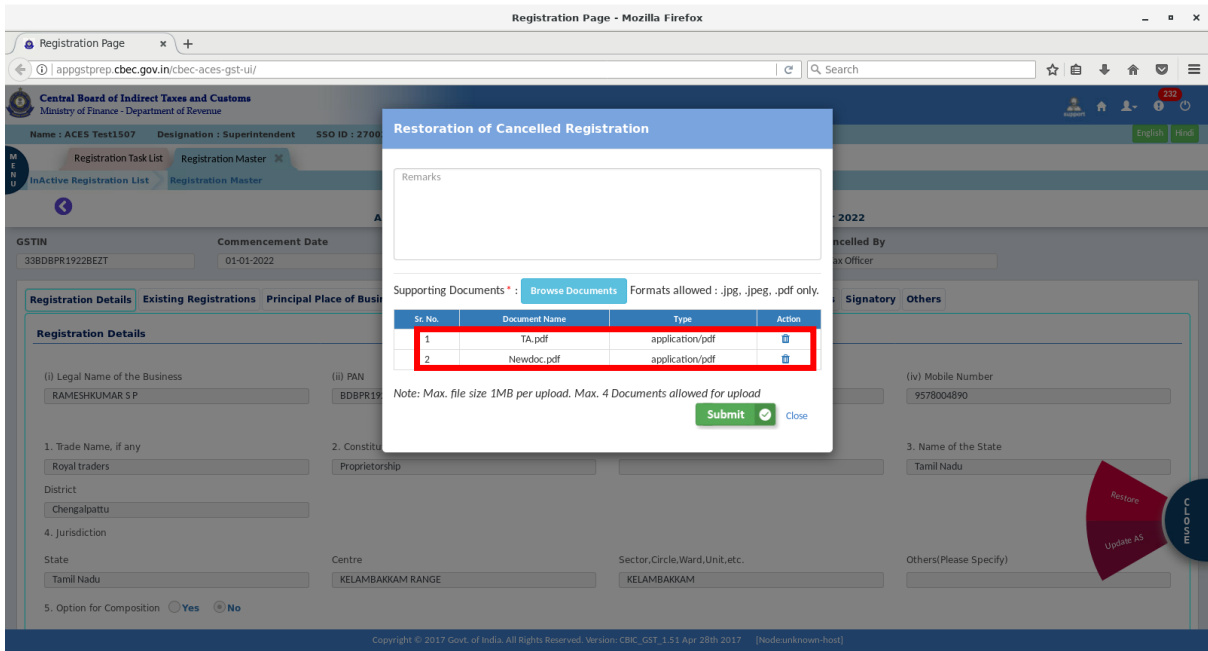
- On click of hyperlink of GSTIN, REG-01 details will be displayed with action button displaying on the right side as below.

- On click of action button, option to 'Restore', pops up as below.

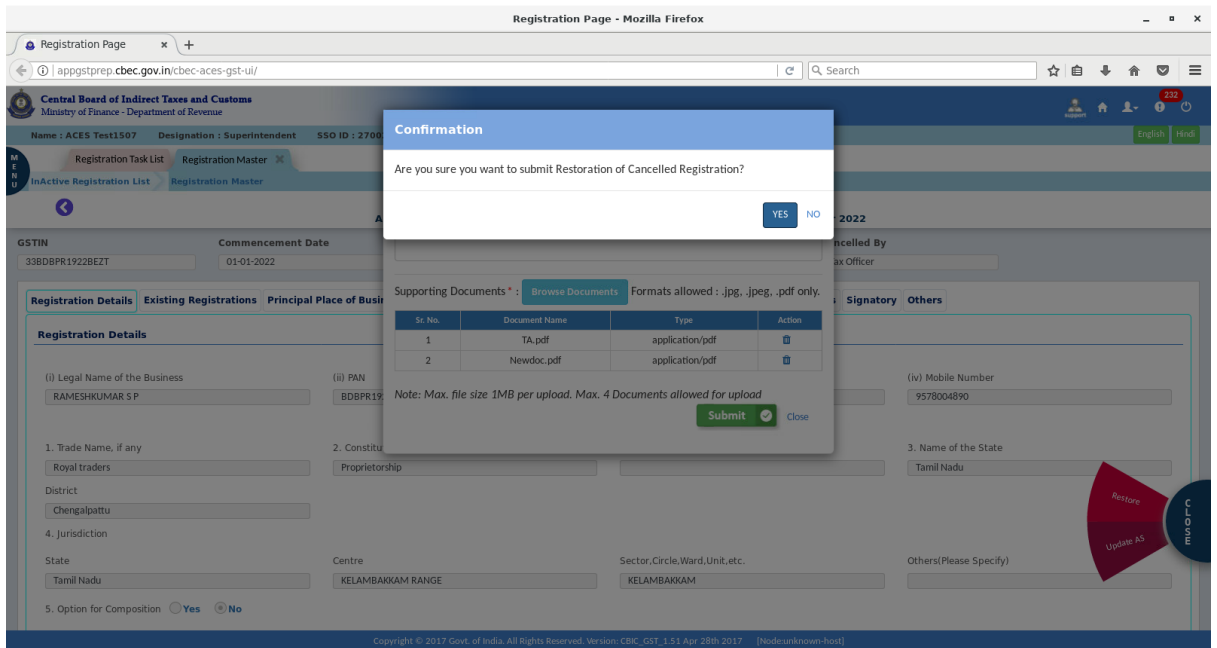

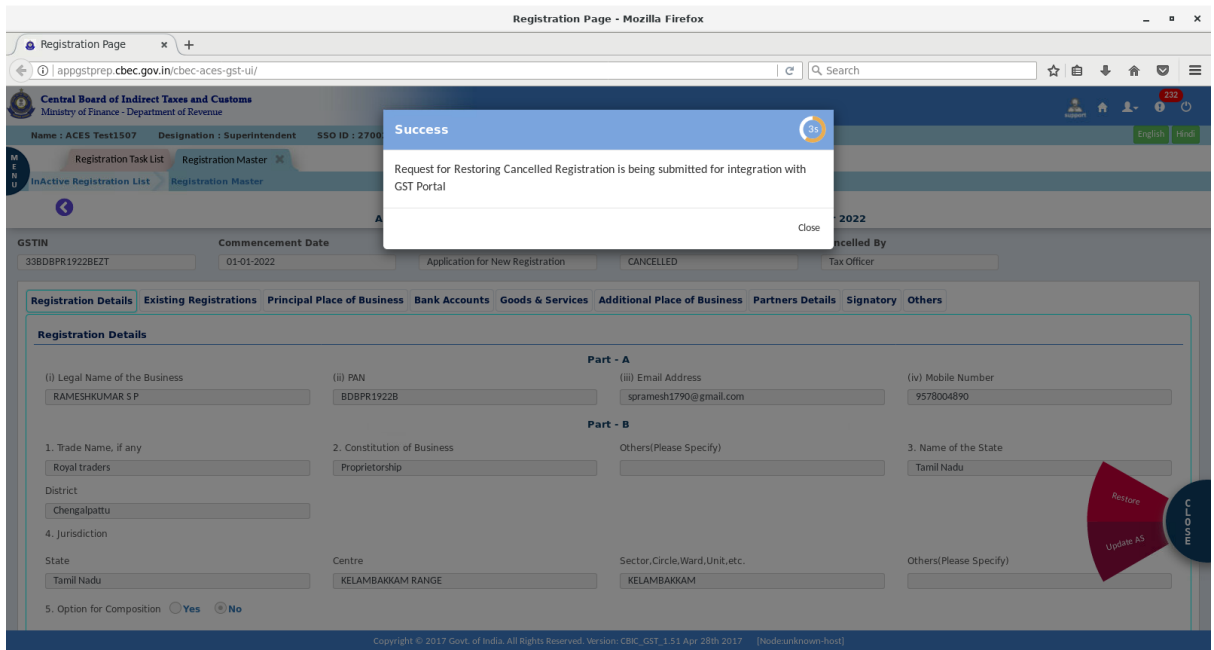
7. On successful upload of documents, the screen appears as under:



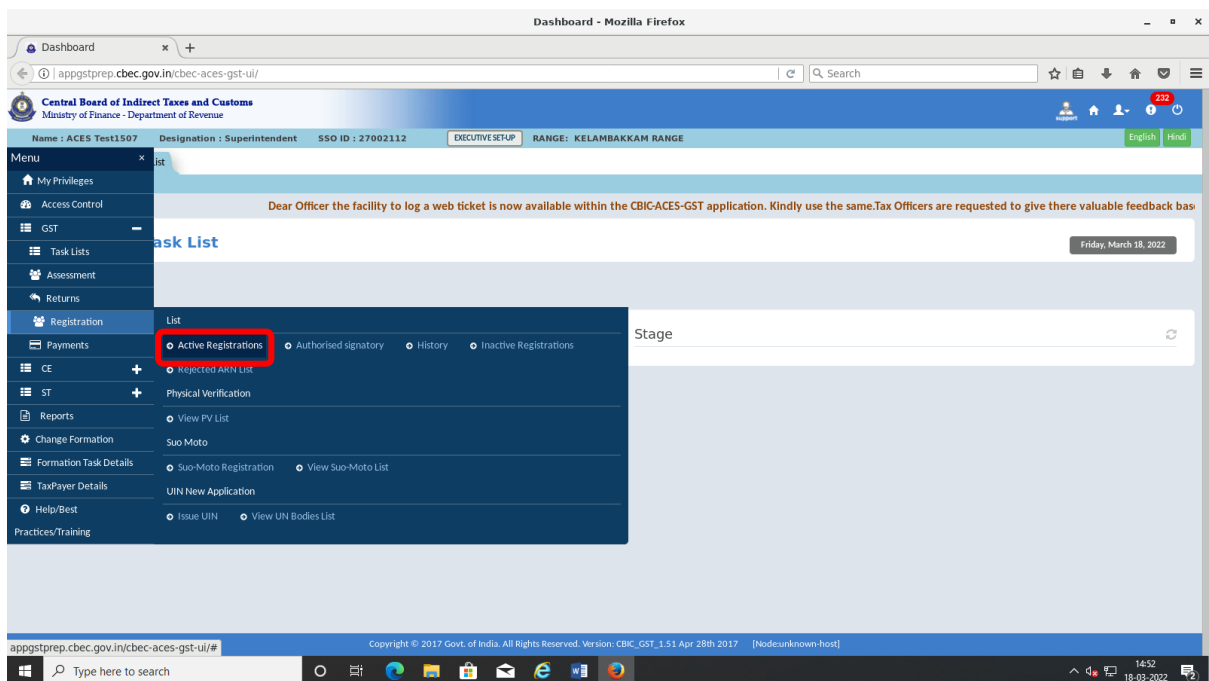
8. On click of 'Submit', confirmation message is displayed as below.



9. On click of 'Yes', a success message "Request for Restoring Cancelled Registration is being submitted for integration with GST portal" is displayed as below.

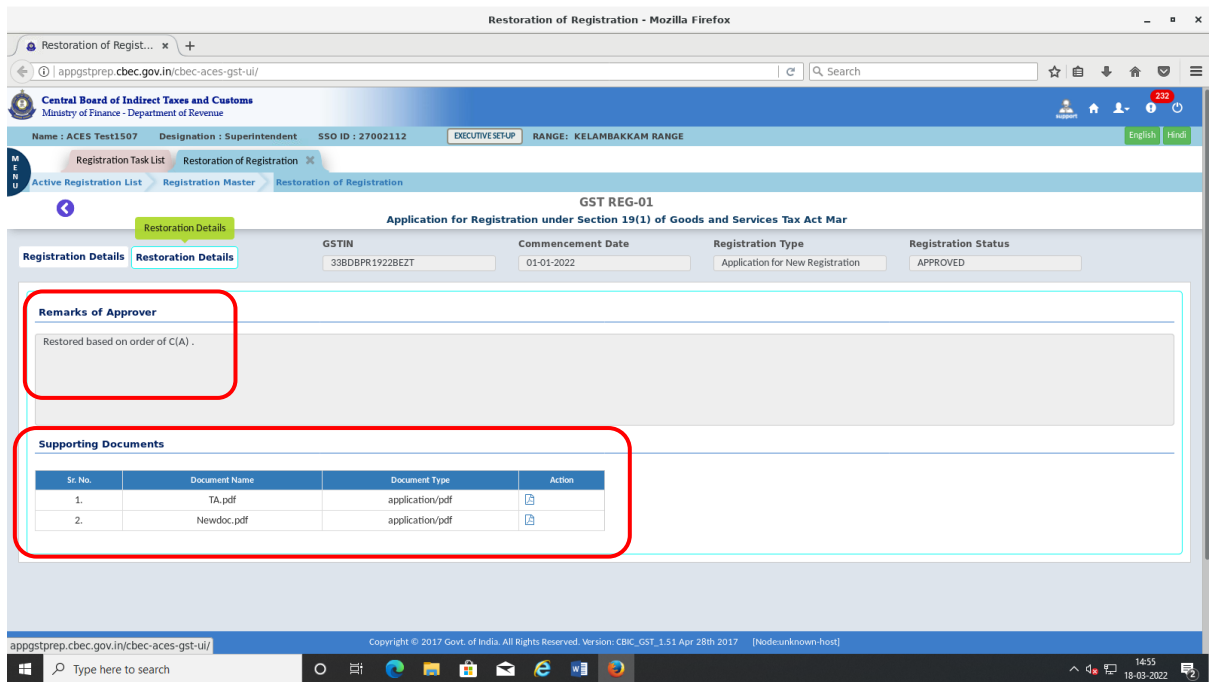


10. After the registration is restored successfully, the registration will appear in 'Active Registration' list page.

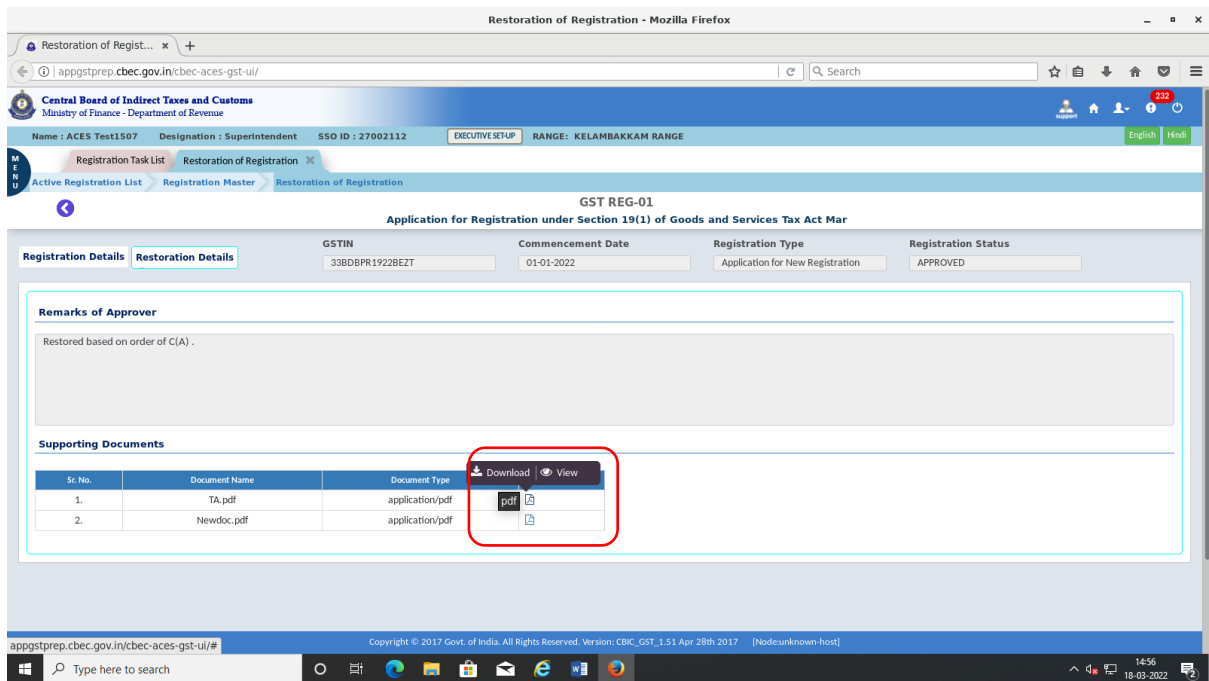




13. On click of Restoration details tab, remarks of officer along with supporting documents which were uploaded can be seen.
