DUTIES AND RESPONSIBILITIES OF THE COMMITTEE

1. This Committee may identify the number of vacancies, selection of specific game/event for sports quota recruitment and number of posts to be allotted to each game/event.
2. Selection of leading local / national dailies for giving advertisement and to publish in the department website by mentioning the specific game/event identified for sports Quota recruitment

3. All applications to be registered and processed and eligible candidates to be called for selection trials
4. Form sub- committee for conducting field trials in each discipline to examine the proficiency of the candidates. The sub-committee should necessarily be headed by an officer of the Department not below the rank of Assistant / Deputy Commissioner.
5. The candidates selection made in the field trials by the well qualified independent selectors nominated by the concerned State / National Sports Development Authorities / Association / Federations.
6. Conduct interview to judge the general intelligence personality traits and physiological make up of the candidates.
7. Rank wise / position wise list of the selected candidates, duly signed by the selectors & countersigned by the Officer - in - charge & sealed in cover at the selection field to be submitted to the Committee. The number of candidates should be at least twice the number of post allotted to each game / event.
8. The Committee / the Officers nominated by the Committee should ensure that the selection trial and the selection is conducted in the most judicious manner.
9. Any other procedures deemed fit for the selection of the meritorious candidates, shall be followed
10. Recommendation to be forwarded to the competent authority for the appointment of the selected candidates under Sports Quota recruitment.

Minutes of all the Meeting to be recorded properly and all communications to the individuals / department / agencies needs prior approval of the Chairman.
